Example: \$300 (cost per hours) X 9 (hours taken) = $\$2700 \times 40\%$ = \$1080 (loan amount)

Students at University Senate approved seminaries can receive a maximum of \$7000 (seven thousand dollars) for a year. Students attending United Methodist seminaries (¶1422.3) can received a maximum of \$10,000 (ten thousand dollars) per year in loans. If a course is dropped or failed, the Registrar of Educational Funding must be notified and reimbursement or deduction will be required.
