FIRST DAY.

Jonesboro, Arkansas, November 19, 1919.

Question 6 was called. Who are received by transfer from other Conferences?

Lee Boliver Ellis and Charles Franklin, Elders from the Eeast Oklahoma Conference; Lawrence L. Cowen, an Elder from the West Oklahoma Conference, and Jason W. Moore, an Elder from the Los Angeles Conference, were announced as Transfers by the Bishop.

Charles Franklin and Jason W. Moore, being present, were introduced to the Conference.

Question 17 was resumed.

The character of J. S. Watson, Riley Jones, J. P. Wheeler, D. N. Weaver, C. H. Nelson, S. H. Blackwell, J. W. Griffin, J. M. McAnally, George M. Hill, J. S. Hackler and Y. A. Gilmore was passed, and their names were referred to the Committee on Conference Relations for the Superannuate relation

The action of the Conference referring the name of W. P. Talkington to the Committee on Conference Relations for the Supernumrary relation was rescinded, and his name referred to the Committee for the Superannuate relation.

W. L. Oliver reported the serious illness of Riley Jones, and an offering, amounting to \$140.00, was taken for him.

After singing "Blest Be the Tie that Binds," a special prayer, requested for H. A. Armstrong was led by W. H. Neal and Bishop Mouzon.

The Secretary was authorized to send a telegram of sympathy to H. A. Armstrong.

Question 13 was called. What traveling preachers and what local preachers have been elected Deacons?

Ira Allen Brumley, Arthur Lee Riggs and James Luther Shelby passed an examination of character and, having stood approved examination on the course of study, were elected to Deacon's orders, and advanced to the class of the third year.

Inis Lothair Claud, John Nelson Russell Score and Luther Elbert Mann passed an examination of character, and, having stood an approved examination on the course of study, were advanced to the class of the third year, being already Deacons.

John G. McCullom passed an examination of character, but was not before the Committee on the Course of Study, continued in class of the second year.

Question 3 was called. Who are discontinued?

Joseph Key Farrish passed an examination of character, but, not having been before the Committee on the Course of Study, and having failed for two successive years to pass his examination, was discontinued.

Question 13 was resumed.

Samuel B. Wiggins passed an examination of character, but, not having passed an approved examination on the Course of Study, was continued in the class of the second year.

Dr. J. J. Morgan of the American Bible Society addressed the Conference.

Question 15 was called. What traveling preachers and what local preachers have been elected Elders?

Elmer H. Cook, Charles Jackson Wade and William Arthur Williams passed an examination of character and, having stood an approved examination on the Course of Study, were elected to Elder's orders.

Olin Learner Cole passed an examination of character and stood an approved examination on the Course of Study, being already an Elder.

John B. Finley, Joseph William Black and William M. Finley, local Deacons, recommended by the Batesville District, were elected to Elder's orders.

Question 1 was called. Who are admitted on trial?

Noel Shepherd Chaney and Porter Weaver, recommended by the Batesville District; James Baker Carter and William Jacob Spicer, recommended by the Booneville District; Ransom Alexander Teeter and Ovid Allen Clark, recommended by the Forrest City District, and Thomas Cleveland Chambliss, recommended by the Searcy District, passed an approved examination on the Course of Study and, upon recommendation of the Committee on Admissions, were admitted on trial into the Traveling Connection.

Question 2 was called. Who remain on trial?

Oliver Mack Campbell passed an examination of character and, having stood an approved examination on the course of study, was advanced to the class of the second year.

James Franklin Carter, Clarence Crow, John G. Ditterline, Ruel Palmer James, William J. Jordan, George L. McNeese, Troy C. Question 3 was resumed.

Silas Walter Adams and Lundy Hughes Ward were discontinued on their own request.

The fact that but one member of the class of the first year had passed an approved examination on the course of study was the occasion of an earnest exhortation from the Bishop to all the undergraduates on the importance of completing their work in the Conference course.

After sundry announcements the Conference adjourned by limitation of time, the Doxology was sung and the Benediction was pronounced by W. F. Evans.

THIRD DAY.

Jonesboro, Arkansas, November 21, 1919.

The Conference convened at 8:30 o'clock, Bishop Mouzon presiding. Hymn No. 1 was sung and R. E. L. Bearden led in prayer. The Bishop read the third chapter of Second Timothy and gave an illuminating interpretation of the scripture read.

The Minutes of the previous day's session were read and approved. The following resolution was adopted:

Inasmuch as there appears to be some misunderstanding of the action taken last year concerning undergraduates,

Resolved: That this Conference agrees that the rule requiring undergraduates to pass their examinations or be located or discontinued on two successive failures shall be interpreted as dating from and after the passage so as not to include the year preceding its passage.

Resolved further: That the Conference reaffirms its purpose in this matter.

Dr. W. E. Arnold, Editor of the Central Methodist, Rev. R. W. McKay, of the Little Rock Conference and Rev. W. A. Swift of Tennessee Conference were introduced to the Conference.

On motion of W. B. Hays the action of the Conference by which Joseph Key Farrish was discontinued, was rescinded and he was continued in the Class of the Second Year.

Question 2 was resumed. Who remain on trial? Joseph Key Farrish.

The Committee on Temperance and Social Service, named by the Presiding Elders on the opening day of the Conference, was by vote of the Conference, discharged.

Question 3 was resumed.

The name of John H. Gholson was called, and he was discontinued at his own request.

Question 13 was resumed.

George Wendell Pyles passed an examination of character, and having stood an approved examination on the Course of Study, was elected to Deacon's Orders, and advanced to the Class of the Third Year.

Question 12 was called. Who are the Deacons of one year?

William Hussey Gayer, Robert Lee Jackson, Albert William Martin, Hezekiah Stewart, Henry Almus Stroup and Albert Leander Platt passed an examination of character and having stood an approved examination on the Course of Study, were advanced to the Class of the Fourth Year.

William M. Adcock, Charles L. Castleberry, George Payne Fikes, Dosson Henry Holland, John Walter Howard, Elmon M. Kelsey, Fizer Montague Noe, T. C. Steele, Alva Rufus Ward and Walter Jacob Williams passed an examination of character, but not having passed the examination on the Course of Study, were continued in the Class of the Third Year.

Question 1 was resumed.

Grover Southerland, recommended by the Fort Smith District, passed an approved examination on the Course of Study, and being recommended by the Committee on Admissions was admitted on trial into the Traveling Connection.

Question 5 was called. Who are readmitted?

Clarence Norman Guice, recommended by the Fayetteville District, and Milton Rozelle Lark, recommended by the Fort Smith District, were readmitted into the Traveling connection, the latter in the Class of the Fourth year.

Question 7 was called. Who are received from other churches as traveling preachers?

On motion the vote was made unanimous.

We, your committee, appointed to investigate the charges of immorality against Rev. E. S. Harris, make the following report. After going carefully into the facts, we deem a trial necessary.

The charge against Rev. E. S. Harris is that for a number of years he has been a habitual user of drugs commonly designated as dope.

We appoint B. L. Willford as prosecutor.

FOURTH DAY.

Jonesboro, Arkansas, November 22, 1919.

The Conference convened at 8:30 o'clock, Bishop Mouzon presiding. Hymn No. 330 was sung and Dr. A. C. Millar led in prayer. The Conference then sang Hymn No. 463.

The Minutes of the previous day's session were read and approved.

The hour having arrived for the reception of the Class into full connection, Ira Allen Brumley, Inis Lothair Claud, Luther Elbert Mann,

George Wendall Pyles, John N. R. Score, James Luther Shelby, being recommended by the Committee on Admissions, and having traveled two years, were called to the bar and adddressed by the Bishop, and having satisfactorily answered the Disciplinary questions, were admitted into full connection by vote of the Conference.

John N. R. Score and Luther Elbert Mann, being Elders and having been received into full connection, it was announced that they had passed the Course of Study in both Third and Fourth Year and they were taken out of the classes.

In the case of E. S. Harris, the following Committee of Trial was appointed: John B. Andrews, Thomas I. Beck, A. C. Chappell, B. W. Dodson, B. C. Few, A. T. Galloway, C. E. Gray, H. H. Griffin, Eli Myers.

W. T. Martin was appointed to represent the Bishop as chairman in the trial. R. L. Jackson was nominated by the Secretary to serve as Secretary of the committee.

The Publishing Committee made its report which was adopted. (See Supplement.)

RESOLUTION FOR AID OF SUPPLIES.

Mrs. F. M. Tolleson, President of the Woman's Missionary Society of the North Arkansas Conference, was introduced and addressed the Conference in the interest of the Woman's work.

The report of the Board of Education was read and adopted. (See Supplement.)

The report of the Epworth League Board was read and adopted. (See Supplement.

The Bishop made a presentation of a Bible to P. W. Furry, a lay delegate from Van Buren, which came from the laymen and the preachers of the Fort Smith District.

The Conference voted that when it adjourned it would adjourn to meet at 2:30 p. m.

Appointments for Sunday services were announced by the Committee on Public Worship.

After various other announcements, the Conference adjourned with the singing of the Doxology and the Benediction was pronounced by J. B. Stevenson.

The Conference reconvened at 2:30 p. m., Bishop Mouzon in the chair.

The 23rd Psalm was read in concert by the Conference.

The Minutes of the morning session were read, corrected and approved.

The verdict of the trial committee in the case of E. S. Harris was read by R. L. Jackson, Secretary of the Committee, as follows:

We, your committee, appointed to try the case of E. S. Harris, find him guilty as charged, and fix his punishment at 30 days suspension from the ministry of the Methodist Episcopal Church, South.

The above verdict is based wholly on the statements made to the committee by E. S. Harris himself.

Memoirs of Mrs. Fred R. Hamilton and Mrs. C. E. Cullom were not read.

Reports of Boards and Committees.

AMERICAN BIBLE SOCIETY BOARD.

The American Bible Society reports a year of unusual interest, the chief of which is its war work. Four and a half million volumes of Scriptures were furnished America's fighting men, and of this number more than a million were Testaments donated outright. These books were supplied in many languages, for not only were the foreign-speaking soldiers of America supplied, but many European soldiers. It was this Book that nerved the men on the eve of battle and chaplains tell us that 99 per cent of the men who fell were found with the Testament in their pocket, or grasped in the hand.

In this connection you will be pleased to know that the Southwestern agency was second in the amount of funds raised for war work and that through the excellent service of our Brother Colquette, Arkansas led all the states of the Southwestern agency in its contribution to the Army Testament Fund, which totaled \$13,000.

The distribution of the Bible Society last year totaled 6,000,000 volumes. We note that the family Bible has been in more demand than for many years, and trust that this indicates a return to family worship.

We now report on a local matter of deep interest to all lovers of the Bible in Arkansas. The disastrous fire that destroyed the Masonic Temple at Little Rock was fatal to the Bible Depository of Arkansas. Brother Colquette reports almost a complete loss, including valuable shipments. It will take \$3,000 to rehabilitate the depository and in view of the depleted treasury of the society, due to war work, the authorities in New York ask if Arkansas can raise this amount. We suggest that this Conference appoint a Sunday for an offering to meet this emergency. We ask your very generous and sympathetic consideration of this matter, it being understood that we will ask the Little Rock Conference to join in this plan.

Let Bible Sunday be an occasion to exalt the Word of God throughout the state. Pastors will be furnished with a pamphlet helpful in preparing a sermon and suggestive program may be had free of charge from Brother Colquette at Little Rock.

RECOMMENDATIONS.

First, that we observe the second Sunday in April, 1920, or as near thereto as practicable, as Bible Day and take a free-will offering toward rehabilitating the Arkansas Depository, which was destroyed by fire August 25, 1919. That we urge our pastors and people to join together on that day in exalting the Word of God and making it possible for the Depository to continue its usefulness.

Second, that our pastors co-operate with the Society in placing the Bible in the homes of our people.

Third, that Rev. D. H. Colquette be reappointed agent of the Society.

BOARD OF CHRISTIAN LITERATURE

Your Board reports as follows:

First, in spite of the conditions arising out of the war, we note that the Publishing House has done a large business and made a reasonable profit;

Second, we were pleased to note that the Christian Advocate was introduced during the year to approximately one hundred thousand Southern Methodists. We also recommend that as far as possible all the brethren and laymen should take the Methodist Review which was never better than at the present time.

Third, the report of the Arkansas Methodist Commission was before us and we feel that they have done wisely in recommending that the price of the paper be continued at \$1.50 as before. We were never so pleased with the paper as we are at present under the very efficient editorship of Dr. A. C. Millar. One of the conditions of the price remaining as before is that of an increased circulation and the Board recommends that the first three months of 1920 be devoted to that purpose. We approve the plans of the management to put the paper in every Methodist home and pledge ourselves to the fullest co-operation in carrying out such plans.

Fourth, we also recommend that an assessment of \$1,500 (\$1,250 granted) be made upon the Conference to be distributed amongst the Districts by the Finance Commission.

Fifth, we recommend that F. S. H. Johnston, J. M. Williams and R. C. Morehead be elected as Commissioners for the Arkansas Methodist.

CONFERENCE BOARD OF CHURCH EXTENSION.

We are glad to inform you that the work of the General Board of Church Extension has continued with uninterrupted progress. The total income from all sources during the year closing March 31, 1919, was \$864,326.85, just \$143,296.85 more than the previous year.

Dr. H. A. Boaz was with us and inspired us with his address.

Our Annual Conference Loan Fund capital is now \$4,383.46 and we added to that at this Conference \$634.59, making a total of \$5,018.05, and we have about \$1,700 to lend at this session.

All moneys given for Church Extension are now sent to Louisville, Ky., and from there are distributed according to appropriations made by this Board. So as to give uniformity all over the Church, your Board recommends that after January 1, 1920, all donations of \$100 or more be secured by a Refunding Bond as required by the Parent Board.

We regret to see the careless way in which the blanks are filled out in make applications to this Board, and we serve notice that if hereafter Boards of Trustees expect to get help from this Board, they will have to come up to the Disciplinary requirements and fill out their blanks as they ought to be.

We have paid over to Dr. R. E. Stout \$106.40, the amount of the collection for work in the C. M. E.Church.

BOARD OF EDUCATION.

We are rejoiced over the improvement in school conditions in all our Church schools.

Sloan-Hendrix has a capacity attendance of 60 pupils, all of high grade. The building is in bad repair and must have attention or be abandoned. A music room, a gymnasium, and an industrial home are greatly needed. It is the policy of the school to confine its activities to a relatively small group rather than to reach out after a larger patronage, a policy which we strongly commend.

Galloway College reports completion of its magnificent dormitory, a capacity attendance of 285 students, a strong school interest, and a truly religious atmosphere in the student body. The Church has in Galloway a plant conservatively valued at \$275,000.00, an endowment of \$60,000.00 and a body of 27 officers and teachers. Larger equipment is the only condition necessary to a doubled attendance and a much larger field of usefulness.

Hendrix College reports an attendance of 332, of whom 221 are in the collegiate department; the acquisition from the S. A. T. C. of several needed buildings, and the completion of the new dormitory, which has been greatly needed for some years. It is pointed out that there are more men in the collegiate department of Hendrix College than in all other colleges of the State combined. The most disappointing feature of the report deals with the ministerial student attendance—there being but eighteen in the college, or one-third of the former percentage of ministerial students.

S. M. U. reports the outlook for the university very flattering. In the theological department the attendance was reduced fifty per cent during the war, the enlistment among the theological students being the heaviest of all the departments, but that the ranks are being rapidly refilled. The spirit of the student body is said to be excellent and the future development an assured fact.

Your Board pledges its hearty support in the educational campaign soon to be initiated. We stand unalterably committed to the policy of fostering our Church schools and of safe-guarding them in every way from such influences as we feel will impair their usefulness or poison the mind and heart of the young men and women who are being trained for service in them.

With regard to the state-supported and controlled schools we make this declaration: that while we look with disfavor upon any attempt as a Church to dominate them, and while we look with even greater disfavor upon any attempt to exploit them or the teachers in the interest of our Church or of any other Church, we do favor most heartily the strongest possible moral support of the State schools. We favor the right sort of men and women as officers and teachers to the end that our children may have the best possible environment and influences, and we pledge our support to the State school authorities in their efforts to secure and hold such teachers in the schools.

We recommend the following appropriations:

For Sloan-Hendrix for the Conference \$2,000.00; for Sloan-Hendrix from the General Board, \$1,000.00; for Galloway College, \$4,500.00; for Hendrix College, \$4.500; for summer school, \$1,000.00; for theological education, \$2,065.00; for general education, \$2,325.00; for printing minutes, \$119.00.

We recommend the following elections: F. M. Tolleson and G. W. Droke as members of the Board of Education to fill the unexpired terms of H. B. Trimble and E. S. Harris; and James A. Anderson and L. E. Moore to succeed themselves as Trustees of Galloway College, and F. M. Tolleson to succeed H. B. Trimble as Trustee of Galloway College; F. S. H. Johnston to succeed himself as Trustee of Hendrix College; G. G. Davidson to succeed J. K. Farris as Trustee of S. M. U.; J. J. Galloway as Commissioner of Galloway College; and F. M. Tolleson as Conference Secretary of Education.

EPWORTH LEAGUE BOARD.

We your Epworth League Board beg leave to submit the following report:

The President of the Conference Epworth League has submitted his report to this body as called for in the discipline and we are glad to note that the Leagues are in a flourishing condition. 140 active Leagues with 407 members are reported by the minutes of this Conference. Over \$1,000.00 was raised the past year by the Leagues for the Africa Special.

The Summer Conference which was held in Searcy was largely attended, and we believe that this gathering means much to the development of the young life in our Church for Christian leadership. We would urge the pastors to encourage more of their young people to attend these annual Conferences of the Epworth League and to support this organization in every other way. We would also urge our pastors to use our District Secretaries not only in promoting the Leagues already organized but in perfecting new organizations.

We wish to call attention to the fact that the Epworth League is raising \$380,000 as an Africa Special, and our Centenary Treasurer, John E. Edgerton reports that up to November 1, over \$25,000 has been paid in on this pledge.

During the Conservation period the Epworth League desires to cooperate in every way possible. In the Evangelistic Campaign that the church is launching the Epworth League seeks to have a part in reaching the unsaved young men and women. A plan submitted by the General Epworth League Board has been adopted by the Ad Interim Committee of the Centenary and this plan calls for a survey of all Churches. Pastors where there are no Epworth Leagues will be expected to gather this information.

Let us ever keep in mind the purpose and mission of the Epworth League: "Conservation of young life and training it for service." We further recommend that Rev. F. A. Lark edit the League page for the Arkansas Methodist.

With the cost of living mounting higher, and with a larger number of men superannuated at this session that at any other since the organzation of our Conference, it is painfully humiliating for us to report that we have no more to distribute among our retired heroes and their widows and orphans than we had a year ago.

We have read carefully and considerately the recommendations of the Board of Finance and are in heartiest co-operation with them in the plans to raise \$10,000,000 for the Superannuate Endowment Fund in the near future.

We have appointed Rev. H. H. Griffin to act as Publicity Agent for this Board in our Conference. We have arranged to have a representative of this Board at each District Conference. We have delegated Rev. H. L. Wade to represent us at a church-wide meeting in the interest of the Superannuate Endowment Fund.

We announce the donation of \$500.00 from Mrs. Minor Gregory of Augusta, which, added to a similar gift from her last year makes \$1,000.00 as a beginning of the \$100,000 Endowment Fund which we hope to raise in our Conference for the Superannuated.

We recommend to all our preachers, especially the younger ones, that they secure life insurance, and since we have an insurance company of our own, known as the Methodist Benevolent Association, we recommend that said Association be patronized when it is convenient.

We have assessed \$20,000 for support of Conference Claimants for the ensuing year, which assessment has been allowed by the Conference Commission on Finance. We have included with this \$20,000 the assessment for the General Superannuate Endowment Fund, which is \$1,800 for the ensuing year or 9 per cent of the total.

THE COMMITTEE ON LAY ACTIVITIES.

This Committee deplores the small salaries paid to many pastors; recommends that a strong campaign be inaugurated to raise salaries; that \$800 may be the minimum salary for single men, and \$1,000 the minimum for married men; recommends the every member canvass, and that systematic business methods be applied to Church finances; recommends the re-election of Brother Will Pyle as Conference Lay Leader; elected Brother P. E. Cooley of Blytheville as Treasurer of Committee. P. W. Furry, Secretary.

BOARD OF MISSIONS.

There has been a most healthy growth in the missionary interest for the past few years. While the year 1917 witnessed the greatest increase in collections in the history of the Mission Board last year even surpassed that high record by one hundred ninety three thousand, four hundred sixty five dollars.

We rejoice also that the income of our Conference Board has gone beyond what it has ever done, and that now we are on a cash basis.

The success of the Centenary has gone beyond our expectation. It calls not for a spirit of pride and boasting, but for humble gratitude to Almighty God for what he has done for us.

We are glad to report that as great as the financial results they are by no means the greatest. The spiritual results are beyond all price.

We must push forward along the lines already begun in the cultivation of stewardship, of life service, and of intercession. We would put special emphasis upon the church-wide revivals to which the Holy Spirit is truly calling us. One of the great factors in the bringing about of this revival is the family altar. The goal proposed by the Centenary Commission is 100,000 family altars. The quota for the North Arkansas

Conference is 2,800. We recommend that we accept our quota and by the help of the Lord go even beyond this and labor to establish an alter in each home in the bounds of our Conference.

We urge the most careful and well organized effort in securing full collections of Centenary pledges. But we no less emphasize the importance of caring for regular sources of income, which form the base line of our finances.

The 10 per cent of the total amount collected on the Centenary pledges, less the Centenary expenses, that comes to the Conference is to be used for the purpose of increasing pastors' salaries and for more adequate support of the home mission fields within the bounds of our Conference.

In the handling of this fund we shall follow the standard plan wrought out and suggested by the Centenary Commission, which is as follows:

Fifty per cent of the Centenary fund shall be used for appropriation on Missionary Charges, 25 per cent as reserve fund, 20 per cent as emergency fund, and 5 per cent for a Preachers' Institute to be held at Hendrix College.

The Mission charges shall be put into three classes: A, B and C. Class A shall comprise those charges which agree to co-operate with the board for the purpose of becoming self-supporting, within four years. Class B, within eight years; or reducing their appropriation 25 per cent and 12½ per cent respectively. Class C shall comprise those charges which are unclassified but must receive aid from the Board.

It is the goal of the board to make as a minimum salary for the married preachers \$1,000—a single preacher \$800. It shall be our endeavor in the use of this fund to reach this goal.

As we cannot know how much of a Centenary Fund is available before the first of January, without which information we cannot intelligently distribute this fund, we shall not until that time make appropriation of the Centenary Fund. The appropriations in this report are made only from the income through the regular sources.

We recommend the appointment of Dr. F. S. H. Johnston as Conference Missionary Secretary.

We recommend an assessment for Home and Conference Missions the same as last year, \$16,492.00. (Granted \$11,000.00.)

THE ORPHANAGE BOARD.

The work of the Orphanage the past year was one of the best in its history. There was less sickness during the year than almost any year during the existence of the Home.

At the close of last year, September 30th, 1918, we had thirty-four children in the Home. We received eighteen children during the year and placed twenty-five, leaving in the Home on September 30th, 1919, twenty-six. During the existence of the Home we have placed three hundred and fifty-six children. We rejected forty applications for children, indicating the care taken by the Board in placing children. We did not refuse admission to any child coming within our rules.

Special gifts in money were received by Brother Thornburgh to the amount of \$743.84 which makes \$40,284.00 he has collected and invested in the property besides the amounts contributed by the Conference.

The receipts from the Conference were again short and wholly insufficient to support the Institution. Of the \$4,000.00 assumed by it, the North Arkansas Conference paid only \$2,122.00, leaving unpaid \$1,878.00, or nearly one-half. The total paid by the two Conferences was \$4,678.00, while the expenses were \$6,420.00. We received \$648.00 for board of certain children and borrowed the balance.

We sincerely hope that the collections now coming in on an assessment of ten thousand dollars will make a better showing. We heartly approve the collections for the French Orphans and every other worthy object, but we must not in the multitude of these calls forget or neglect our own orphans.

We feel that both in our churches and contributions our own orphans should have first place. It is a shame to allow our institution to borrow money every year to meet current expenses while our people give liberally to other institutions.

We urge our preachers and people to remember the Methodist Orphanage in their Christmas offerings.

The thanks of Arkansas Methodism are due Hon. George Thornburgh for his long and faithful service in connection with our Orphanage. Let us give this worthy institution the support it so richly deserves.

COMMITTEE ON SABBATH OBSERVANCE.

There are two conceptions of the Sabbath extant in our country: One is that Sunday is a holiday, the other, that it is a holy day. The one is termed the European Sabbath; the other the American Sabbath. We may not realize it but these two ideas are right now engaged in a death struggle, and our civilization is as stake.

On the side of the European Sabbath are arrayed all the powers of darkness, such as the radical element of whatever name, and Commercialism which knows no morals but which, for a material consideration would strangle every noble Christian impulse, tear Christ out out the hearts and lives of our people, and enthrone in Christ's stead Mammon with his horrible reign of black despair.

And, sad to say, the European conception of the Sabbath day has cast its blight upon the Church of God, so that our people have lost the proper Sabbath conscience, until such practices as Sunday automobile trips, picnics, swimming parties and excursions are indulged in without the least remorse of conscience, the result being empty pews and an impotent church.

Now, on the side of the American conception, alone stands the Protestant Church; and, by reason of the worldliness in the church, as above indicated, the Protestant Church does not stand with a solid front.

Brethren, as we love our Lord and His Holy Church, and pray for God's will to be done on earth as in Heaven, let us do all in our power to save our Holy Sabbath.

Number of Sunday Schools, 514; Officers and Teachers, 4,258; Pupils, 46,612; Total Enrollment in Sunday Schools, 50,870; Enrolled in Home Department, 591; Number on Cradle Roll, 1,721; Number of Wesley Bible Classes, 100; Teacher Training Classes, 30; Sunday School Pupils Joining the Church, 1,980.

Amount Raised for Missions, \$10,548; Sunday School Day Fund, \$985; Sunday School Supplies, \$532; Other Objects, \$10,725; Total Centenary Pledges for 321 Schools, \$77,313; Paid on Centenary, \$8,000; Grand Total, \$52,790.
