(The Conference decided that its annual notation should date from the time of the organization of the Arkansas Conference in 1836, instead of following the date fixed by the consolidation of the Arkansas and White River Conferences, when the name was changed to North Arkansas, in 1914).

H. L. Wade reported his work as Conference Director of Superannuate Endowment.

Carter, Eli Myers, E. W. Nelson, A. W. Russell, S. S. Key, J. M. McAnally, J. K. Farris, W. T. Martin, G. M. Barton, J. D. Roberts, C. F. Wilson, A. T. Galloway, V. B. Utle, A. L. Cline, D. N. Weaver, J. C. Weaver, E. N. Bickley, J. F. Jernigan, T. A. Bowen, Henry Hanesworth, J. B. Andrews, J. T. Hood, J. R. Ashmore, I. D. McClure, J. H. Cummins, and James A. Dr. Franklin Moore of the Oklahoma Conference was introduced to the Conference.

Various announcements were made. The Conference adjourned with the benediction pronounced by Dr. Franklin Moore.

### THIRD DAY

The Conference met at 8:30 a. m., Bishop Moore presiding. Hymn No. 378 and No. 116 were sung. J. M. Harrison led in prayer. The Conference sang Hymns No. 145 and No. 147. Bishop Moore read a lesson from the first chapter of Colossians and addressed the Conference on the Ministries of the Church. Hymn No. 142 was sung.

The Minutes of the preceding session were read and approved.

Dr. E. B. Hawk, Dean of the School of Theology of S. M. U., Dr. C. O. Ransford, one of the editors of the Christian Advocate, Rev. John I. Butteman of Southwest Kansas Conference of the Methodist Episcopal Church, Rev. H. S. Anglin of the St. Louis Conference, Rev. O. G. Andrews of the Memphis Conference, Rev. E. T. Miller, Rev. J. L. Dedman, Rev. J. D. Hammons, Rev. S. M. Goddard, and Rev. L. E. N. Hundley of the Little Rock Conference, and Rev. W. J. Mayhew, of the Northwest Texas Conference were introduced to the Conference.

Smith A. Johnson and Mrs. W. V. Womack, alternate delegates from the Jonesboro District, were seated in the place of W. R. Stuck and C. J. Chapin.

On behalf of the preachers of the Helena District, W. H. Goodloe presented a Bible and Hymnal to G. G. Davidson and Mrs. Davidson as a token of appreciation of the work done by them during four years on the Helena District. G. G. Davidson thanked the preachers for their kindness and faithful work.

J. W. Crichlow spoke in appreciation of Rev. and Mrs. Davidson.

J. W. Workman, and H. H. Griffin, Presiding Elders, reported their work in the Fayetteville and Fort Smith Districts.

William Sherman, Presiding Elder of the Conway District, reported the work in his district.

QUESTION NO. 1 was called: *Who are admitted on trial?*

Lloyd Milton Conyers, recommended by the Batesville District Conference, having stood an approved examination in the course of study and being recommended by the Committee on admissions, was admitted on trial into the traveling connection by vote of the Conference.

QUESTION NO. 3 was called: *Who remain on trial?*

Hubert E. Pierce, James Upton, Body W. Johnston, Everett Patton, John M. McCormick, W. S. Erwin, W. F. Cooley, and R. L. Franks, having stood an approved examination on the course of study, were advanced to the class of the second year.

QUESTION NO. 2 was called: *Who else is in the class of the first year?*

Irl Bridenthal and F. M. Dodson, not having stood an approved examination on the course of study, were continued in the class of the first year.

QUESTION NO. 17 was called: *What traveling preachers and what local preachers have been elected deacons?*

Raymond Arthur Dorman, having stood an approved examination on the course of study and having been two years on trial in the traveling connection, being recommended by the Committee on Admissions, was advanced to the class of the third year and elected a deacon.

Dr. E. B. Hawk, Dean of the School of Theology of Southern Methodist University, Dr. J. H. Reynolds, and Bishop Moore addressed the Conference in the interest of Ministerial Training.

The Conference voted to make the First National Bank of Conway the official depository for Conference funds during the session.

Miss Edith Martin, a missionary returned from Africa, was introduced to the Conference.

Various announcements were made.

The Conference adjourned with the Doxology and the Benediction pronounced by J. M. McAnally.

#### FOURTH DAY

#### MORNING SESSION

The Conference met at 8:30 a. m. Bishop Moore presiding.

Hymn No. 39 was sung. F. M. Tolleson led in prayer. The Conference sang Hymns No. 405 and No. 401. The first responsive reading for the Forty-ninth Sunday was read. The Gloria was sung.

QUESTION NO. 6 was called: *Who are admitted into full connection?*

Raymond Arthur Dorman, being two years on trial and recommended by the Committee on Admissions, having given satisfactory answers to the disciplinary questions, was addressed by Bishop Moore on the work of this ministry, and was received into full connection by the vote of the Conference.

The Minutes of the previous session were read and approved.

The presence of Chas. A. Stuck, a delegate from the Jonesboro District, and of J. C. Ashley and Homer Fox, delegates from the Batesville District, was noted.

QUESTION NO. 21 was called: *Who have been recommended by a District Conference for recognition of their orders?*

On the recommendation of the Searcy District Conference the Conference voted to recognize the orders of Clifford Bradley Pace, an elder in the Cumberland Presbyterian Church.

QUESTION NO. 47 was called: *Where shall the next session of the Conference be held?* Jonesboro and Batesville were nominated. The Conference voted to hold the next session of the Conference at Batesville.

The following resolution was adopted:

#### RESOLUTION

Resolved: That hereafter the North Arkansas Conference shall instruct the Statistical Secretary to hire the statistics tabulated in order to release the preachers, who heretofore have done this work to attend the sessions of the Conference. The expense of this work shall be included in the expense of publishing of the Minutes.

Report No. 2 of the Board of Christian Education was read. J. Q. Schisler, H. L. Wade and Ira A. Brumley spoke to the report. The report was amended and adopted and admended.

On a motion by William Sherman the Conference voted to meet in memorial session at 2:30 Sunday afternoon, and thereafter to make it the policy of the Conference to hold memorial sessions on Saturday afternoon instead of Sunday.

The Conference voted that when it adjourned it be to meet for an afternoon session at 2:00 o'clock.

The report of the Centennial Commission was read. Dr. O. E. Goddard, Dr. J. M. Williams and Bishop Moore addressed the Conference on matters of history and policy of the Church.

Dr. James A. Anderson spoke in behalf of distribution of the History of Methodism in Arkansas, preparing for early publication.

The report of the Board of Lay Activities was read and adopted.

QUESTION NO. 43 was called: *Who is elected Conference Lay Leader?*

C. A. Stuck was elected Conference Lay Leader.

The report of the Committee on District Conference Journals was read and adopted.

J. Q. Schisler and J. S. Seneker were granted leave of absence.

The Conference sang the doxology and adjourned with the benediction pronounced by J. T. Wilcoxon.

## FOURTH DAY—AFTERNOON SESSION

The Conference met at 2:00 o'clock, Bishop Moore presiding.

Hymn No. 282 was sung. W. H. Goodloe led in prayer. Hymns 281 and No. 562 were sung.

Bishop Moore expressed appreciation of the presence and aid of Dr. C. C. Washburn, and Mrs. C. E. McNutt in the use of the new Hymnals in the singing of the Conference. On motion of B. C. Few, the Conference voted to join Bishop Moore in this appreciation.

Hymn No. 555 was sung.

The Minutes of the morning session were read and approved.

Question No. 24 was called: *Who are Superannuated?*

The report of the Committee on Conference relations was read and adopted answering this question.

QUESTION NO. 23 was called: *Who are Supernumerary?*

Report No. 2 of the Committee on Conference Relations was read and adopted answering this question.

The report of the Board of Finance was read. H. L. Wade spoke to the report. On motion of the E. H. Hook the report was amended. L. E. Mann spoke to the report and announced the rate for the next year as \$1.87 per month per thousand dollars, and 13c per thousand for administration or \$2.00 net per month per thousand dollars. A. W. Martin spoke to the report. The report was adopted.

A telegram of greeting from H. H. Hunt, who is ill at home was read by the Secretary.

The report of the Commission on Budget was read. J. W. Crichlow spoke to the report. The report was adopted.

Report No. 1 of the Board of Christian Literature was read and adopted.

Report No. 2 of the Board of Christian Literature was read. A. N. Storey, J. W. Crichlow, A. C. Millar, S. M. Yancey, and A. W. Martin spoke to the report. On motion of A. W. Martin the report was amended to request the Commission to make an adjustment of the salary account. The report was adopted.

Dr. Ivan Lee Holt pastor of St. John's Methodist Church in St. Louis was introduced to the Conference.

Dr. C. O. Ransford addressed the Conference in the interest of the Christian Advocate.

QUESTION NO. 3 was resumed. The Committee on the Course of Study reported that Raymond L. Franks had passed a satisfactory examination on the course of study and he was advanced to the class of the second year.

The report No. 2 of the Board of Finance was read and adopted.

The report of the Orphanage Board was read and adopted.

Guy Murphy read the report of the Treasurer. The report of the Auditing Committee was read. The reports were filed with the Secretary.

Report No. 1 of the Board of Missions was read. Dr. O. E. Goddard, J. L. Rowland, and J. J. Decker spoke to the report. The report was adopted.

Report No. 2 of the Board of Missions was read and adopted.

Mrs. E. F. Ellis, Conference President of the Woman's Missionary Society was introduced to the Conference, and addressed the Conference on the work of the Woman's Missionary Society in the Conference.

The report of the Board of Church Extension was read and adopted.

The Report of the American Bible Society Board was read and adopted.

M. J. Russell, Superintendent of Valley Springs Training School addressed the Conference reporting the condition and work of the School. On motion of M. J. Russell the conference authorized the Trustees of Valley Springs Training School to put on a campaign to raise \$5,000.00 to liquidate the indebtedness of the school.

S. M. Yancey, representing the Western Methodist Assembly addressed the Conference.

The Gavel presented by S. B. Wilford to the Conference was placed in the hands of the Secretary for keeping through the Conference year.

The Committee on Public Worship reported the preaching assignments for Sunday.

The Conference adjourned with singing Hymn 416 and the benediction pronounced by Bishop Moore.

## FIFTH DAY

## LAY ACTIVITIES

The Board of Lay Activities of the North Arkansas Conference submits herewith its report as follows:

We count there are two principal questions which we would hold before our laymen for the coming year. The first is

*Temperance and the Liquor Traffic*

Throughout its entire life the Methodist Church has espoused the cause of Temperance and has opposed the use of intoxicating liquors. True, our forefathers indulged at times in this practice which was not known at that time to have as many attendant evils as we have since learned that it has. We call before the bar of enlightened opinion of the Laymen in our church, the liquor traffic and demand that it show a single benefit this traffic has achieved without the concurrent loss of much greater values in our communities and society in general. We recognize that there is a definite increase of drinking and intemperance developing among our people as well as others. All too many Methodists are drinking today.

The answer to this question can and should come from the pew as strongly as from the pulpit and we recommend that our laymen face this situation squarely, bravely, and in a Christian manner, to the end that Methodists may be counted among the ranks of those who most certainly will fight to improve the deplorable situation that exists today.

We commend most heartily the W. C. T. U. and the Arkansas Anti-Saloon League and we pay particular tribute to our brother, Rev. J. H. Glass, who is working so nobly in this cause. Also we commend our Baptist brethren for their stand on this question and pledge them our cooperation in this important cause.

While the first question is of paramount importance, it cannot be fully achieved until we face and answer properly the second question, which we choose to call

*The Christianization of the Home.*

God in his infinite plan has chosen to bless most of our homes with children. What they will be and do lies largely in our hands as laymen. Our schools and colleges are helpless to reform lives that have been previously allowed to become warped and twisted because of the attitudes and practices of fathers and mothers. Society and not even the church can make godly men and women of its offspring unless Godly fathers and mothers talk plainly, freely, and often to their children about the principles of Jesus and—what is more—strive to live before them as we are admonished to do in our ritual, the life that becometh the gospel. We call upon our brother laymen to put this into practice for a year at least and learn what benefits can be really achieved for the Kingdom of God and for the lives of our children.

Finally, we urge our brethren to pay more attention to our church benevolences, realizing that this is a real and tangible means of showing our love for the church and the kingdom. Also we recommend that our people cooperate with our preachers in any and all evangelistic efforts of our church in order

that we may acquire a more vital experience with the Master and a greater sense of responsibility toward Him and His cause.

We commend the Arkansas Methodist to our people and urge more Methodists to read this worth while paper.

## CHRISTIAN EDUCATION

## REPORT NO. 1

Upon its own initiative your Board wishes to warn the Conference of what may become a serious situation at Hendrix College. The remarkable achievements of the college during the depression have misled our people into thinking that the college is rich and that the church does not need to do anything for it. Upon its own responsibility this Board devotes its first report to arouse the church to the dangers in the situation.

Let facts speak for themselves:

1. The Conferences in unifying their higher educational work on one campus doubled the burden upon Hendrix College, requiring twice the faculty, the income, the physical plant and endowment.

2. This burden was rolled on to the college just as we entered the depression when the church felt itself unable to do anything to help the college bear the burden. On this account the Trustees have not called upon our people for any aid.

3. In this situation the college turned to the Foundations in New York, the General Education Board, the Carnegie Corporation and the Juilliard Foundation. Happily the Foundations afforded temporary relief by providing some \$300,000 for buildings and about \$25,000 a year for increasing the professorships required by the action of the Conferences in their unifying program. The church has done nothing to aid in this advance.

4. The danger to Hendrix and therefore to the church is that the Foundations are withdrawing this temporary aid to the salary budget and are throwing it back upon the church. The faculty cannot bear it because their salaries have been cut deep. The whole rich program is at stake. What will this Conference do about it?

5. Hendrix College by this temporary aid and by the brilliant work of the faculty has taken a national position. The issue before us is whether the college will lose this proud place of service.

6. Your Board says "No, we must not back down. Methodism never retreats." Let us sound the note, "Forward March!"

7. Accordingly, your Board recommends that this Conference hereby record its high appreciation of the great service of the Foundations in coming to our rescue in a financial crisis, that it pledge to the Board of Trustees its loyal support in meeting the crisis, that we recommend that the program of temporary relief and of doubling the physical plant and endowment be made an integral part of the centennial celebration and that as an earnest of the Conference's deep concern it direct its Board of Christian Education to act as its agent in collaborating with the Board of Trustees in working out and in putting into operation ways and means of financing both the temporary and permanent needs of the college.

## REPORT NO. 2

We heard with interest and pleasure the report of the President of Hendrix College showing that the college is forging ahead in its great work under the fine statesmanlike leadership of Dr. J. H. Reynolds.

We recommended: That college week be observed in each local church in the Conference; and, that a free-will offering be taken to be used for Scholarship Fund for Ministerial Students, and the President of Hendrix College and Executive Secretary of the Board of Christian Education be responsible for the administration of this fund.

The superintendent of Valley Springs Training School reported an increased enrollment and a lively interest among the students.

The Treasurer's report was audited and the books found in excellent condition. The Board expresses its appreciation of the fine service of C. D. Metcalf as treasurer.

The following were elected as members of the Conference Staff:

Director of Children's Work: Mrs. Ira A. Brumley.

Director of Young People's Work: Nat. R. Griswold.

Director of Adult Work: Dr. J. M. Williams.

C. D. Metcalf was re-elected treasurer of Board of Christian Education.

Reports were received from Executive Secretary, Extension Secretary, and Age Group Directors and approved by the Board.

Western Methodist Assembly reported by Dr. A. C. Millar, showing improvement in financial condition.

We recommend that G. G. Davidson, H. C. Henderson, Cecil R. Culver and Conner Morehead be elected to fill vacancies in Board of Christian Education.

We recommend that Dr. F. M. Tolleson, Rev. W. V. Womack, and Ira A. Brumley be our members of Committee for Inter-Conference Wesley Foundation Work.

The Budget Commission was requested to grant an assessment of \$16,000.00 to be divided as follows:

#### BOARD OF FINANCE

##### REPORT NO. 1

To the Bishop and Members of the Annual Conference:

From the report of the General Board of Finance \$156,052.00 was available for distribution on July 1, 1935. Of this amount \$3,415.00 was apportioned to the claimants of the North Arkansas Conference. In addition to this we have just received \$1,686.82, being income from the North Arkansas Conference Superannuate fund amounting to \$56,360.67 which is handled by the General Board. This income represents 3 per cent on the total capital. We appreciate the efficient manner in which Dr. L. E. Todd, the General Secretary, has handled this fund.

In compliance with the law which requires that the Secretary of the General Board be furnished the service years of all the claimants, we designate W.



L. Oliver and Jefferson Sherman a committee to ascertain the service years of all claimants coming on the list from time to time.

We call attention to the roll of claimants with addresses in the minutes; and request that any pastors knowing errors in the addresses notify W. L. Oliver.

The following claimants have died during the year: W. W. Anderson, J. T. Gossett, M. F. Johnson, Mrs. Eliza Edwards, Mrs. W. M. Watson.

### RECOMMENDATIONS

We recommend:

(1) That each charge which has an unpaid quota balance on Superannuate Endowment pay or readjust by formal action, and send notice of such action to H. Lynn Wade.

(2) That a free will offering be taken at one of the regular Sunday services to apply on this fund, and that each Presiding Elder make this an item of special consideration at the District Conference.

(3) We most respectfully recommend that the Commission on Budget assess \$1,750.00 in the regular way for our claimants, and, in addition, \$750.00 for emergencies.

(4) We recommend that H. Lynn Wade be appointed Conference Director.

### SUPERANNUATE HOMES

We are informed that many of our Conferences in the connection are securing and maintaining homes for their claimants.

We again call attention to the fact that our own Conference Board of Finance is incorporated under the laws of the State of Arkansas for this purpose also. We urge our pastors and people to aid us in securing superannuate homes in our Conference. This may be done by calling the attention of our people to this fine method of carrying out the purpose of the church in making provision for our claimants. We suggest that any information that might lead to securing such homes be communicated to H. Lynn Wade, Chairman of the Board of Finance, who is hereby designated by the Board for such purpose.

### GROUP INSURANCE

Another matter of Special interest has been the carrying of group insurance by the members of this conference in a voluntary way.

We recommend that this Group Insurance be continued, and that all our members avail themselves of the opportunity of providing for their dependents in case of death, and for themselves in case of total disability, and of thus assisting their less fortunate brethren who could not secure insurance but for the group.

We further recommend that any member who has insurance with this group, unless he notifies the Secretary in writing to discontinue his insurance, be held

morally and legally responsible for his unpaid premiums, and be dealt with accordingly.

We submit the report of the Insurance Secretary, L. E. Mann, and request that he be continued in this office with full authority to act as our agent according to our contract with him and the Equitable Insurance Co.

## AMERICAN BIBLE SOCIETY

All those who are acquainted with the work of the American Bible Society know that this year we are in the midst of commemorating the Four Hundredth Anniversary of the printing of the first complete Bible in the English Language. It is the deep desire of those who are directing the destinies of the Society that these anniversary celebrations shall make history and not spend themselves merely gloryfying our past achievements.

Since our church, along with a number of other evangelical churches supports the work of the American Bible Society, we, your committee, on the

American Bible Society, urge that the claim of the society upon us pastors, and leaders among the laity, be placed second to none. We urge that all our leaders inform themselves better with reference to the workings of the American Bible Society and its great mission in extending God's Kingdom here in America and abroad. Rev. J. J. Morgan, Dallas, Tex., who has the agency for the American Bible Society for the Southwestern States will gladly furnish us any information along this line of which we stand in need.

The urge that our preachers in all their work, and our teachers in the local church schools strive to bring about a genuine revival in Bible reading and Bible study. And we urge the reading and study of the Bible itself—not merely reading and studying books about the Bible. This reading and studying the Bible itself we urge because history teaches us that such searching of the Scriptures never fails to come to a fine fruitage in the saving of many individual souls and the building up of God's Kingdom in the world.

Having before us the goals mentioned above we offer for adoption the following resolutions:

First: Be it resolved that we, the members of the North Arkansas Conference, each and all, now determine that we shall from this time forward daily devote more time than heretofore to the reading and study of the Bible, and that in all our study of the Scripture we study first of all the Bible itself.

Second, be it resolved that each of us pastors in the very first days of the new conference year write Rev. J. J. Morgan, a Methodist preacher, and agent of the American Bible Society, Dallas, Texas, for a catalogue of Bibles and New Testament, and that we order from this catalogue a few of sixty cent Bibles, the thirty cent Bibles, the five cent New Testaments, and the penny portions, enclosing money for the same.

Thirdly, be it resolved that we show these Bibles and New Testaments to our people, and sell to such as may wish to buy.

Fourthly, be it resolved that we as pastors, voting for the adoption of these resolutions pledge ourselves to hold sometime before January 1st a service commemorating the Four Hundredth Anniversary of the printing of the first complete Bible in the English Language, striving to make of this a history-making service.

We recommend the appointment of Lester Weaver to fill the vacancy in the Board caused by the death of J. R. Jordan.

#### REPORT OF THE CENTENNIAL COMMISSION

Your Centennial Commission representing the two Annual Conferences, having carefully considered the question which led to its formation, submits the following suggestions in harmony with the plans approved last year.

Because 1936 is the 100th year since the Arkansas Conference was organized at Batesville and because of the agreement that the 50th anniversary of the founding of Hendrix College should be continued jointly with the Centennial

Celebration, and, further, because it is the desire of our leaders that Evangelism be promoted and stressed, we submit the following recommendations:

1. That, at the Christian Education Institutes which are usually held soon after the Annual Conference adjourn, all of the plans and objectives of the Centennial Commission be presented so that, throughout the year, they may be kept in mind and constantly emphasized.

2. That the Institutes to be held under the direction of the Board of Missions early in the year be so planned as to command the ablest speakers possible, especially speakers who will concentrate the thought of the Church upon the supreme place of Evangelism in Methodism; and that the Conference Committee on Evangelism co-operate with the Board of Missions at these Institutes in making Evangelism outstanding and a source of inspiration; and that these Institutes be followed by great Centennial Messages on Evangelism in all the local churches under the direct leadership of the Presiding Elders. In the larger churches special evangelistic programs, using distinguished speakers, should be carried out by pastors helped by the Committee on Evangelism. The whole program should be designed to present to the minds of all our people the Evangelistic Mission of historic Methodism and to impress them with the need and desire for a gracious and sweeping revival in every charge in the State.

Your Commission is having a popular booklet prepared on Arkansas Methodism, by Dr. Elmer T. Clark, to be sold at these Institutes at a low price with the view to having them used in study classes in the local churches under the direction of the Board of Education.

3. That the Presiding Elders be requested to schedule their District Conferences consecutively so that one or more outstanding men may be brought to the State to give great addresses on Methodism at each District Conference. It is requested that Bishop John M. Moore be one of these speakers and that Dr. J. M. Williams, chairman of the Committee on Education of the Centennial Commission, be given a place on these programs.

4. That the Pastors' School at Conway for 1936 be known as the Centennial Pastors' School; that the program center around the great fundamental principles of Methodism; and that some outstanding speaker be engaged to deliver a series of strong addresses on the prominent phases of Methodism.

It is recommended that a great pageant be the climax of the Pastors' School and that if possible, this pageant be repeated at strategic centers. Arrangements are in progress for writing this pageant, and representatives of Hendrix College have graciously consented to put it on at Conway.

It is further recommended that the Young People's Assemblies that meet at Conway prepare and put on a Centennial pageant as a principal feature of their program, and that they have a special Centennial speaker.

We are informed that, at their annual meetings in the spring, the Woman's Missionary Societies of the two Conferences will, in joint session, have a Centennial pageant portraying the history of their work; and we heartily commend this purpose and promise full co-operation in any way that they may desire.

If it can be done, we suggest that abridged pageants may be prepared for use in the smaller churches, possibly with local talent and with a touch of local color.

The whole purpose of these Pageants is to attract the attention of large groups and give them a vivid and unforgettable picture of the history of Metho-

dism so that old and young alike may be impressed with the achievements of the past and be led to undertake even greater things in the future.

5. That, in view of recent General Conference legislation merging the three Boards concerned with Christian Education and also in view of the unifying of college education in our State, the Conference Board of Education and the Educational Committee of this Commission, of which Dr. J. M. Williams is chairman, use every possible means to present to our church members the unified program of Christian Education; that they encourage our young people to realize the three-fold objectives of education, the perfecting of body, mind, and spirit, and that special efforts be made to realize the central objectives of recent legislation, that is, the creation of a very intimate relation between the local churches and our own Hendrix College so that there may be a strong practical and spiritual tie binding them together. Two features of the Hendrix Semi-centennial have been completed. The College now comes to the third element; namely, its forward movement to equip itself with buildings and to supplement its present endowment. We commend this to the serious and sympathetic attention of Arkansas Methodism.

It is the desire of your Commission to make clearer and stronger in the minds of our people the reasonableness and the necessity of education that is wholly under the dominance of the Christ spirit in all the relations of life with a view to producing better people in the church and of winning the unsaved to accept Jesus Christ as Saviour and Master. While, in presenting the achievements of Methodism, the essentials of doctrine and polity may not be ignored, it should be understood that the great underlying purpose of this movement, is to challenge our people to more heroic and sacrificial living. It is hoped that nothing may be permitted which can be interpreted as carrying the implication of denominational vanity or rivalry; but that Methodism may be presented simply as one of the great movements of Christianity intended to carry out the Master's command to evangelize all people. In other words, the proposed celebration should be inspired by the purest Christian spirit and the holiest motives.

6. Because this program cannot be effectuated without cost, your Commission again requests each Annual Conference to include in its askings \$1,000 for this year.

## BOARD OF MISSIONS

### REPORT NO. 1

The command of Christ stands, "Disciple the nations." In every vision stands the man of Macedonia with strong appeal, "Come over and help us." Human needs are universal and all but overwhelming. Lack of vision and generosity on the part of many and circumstances over which we have no control have added to the difficulties of missionary endeavor and evangelistic advances.

We call your attention to the very great importance of the Benevolent

Fund. It is the backbone of our whole missionary program. We must have as pastors and people an increasing appreciation of our Benevolences.

We make the following recommendations:

(1) Let emphasis upon evangelism be given by every pastor and organization in the church.

Let revivals be held in every charge.

Every pastor in self-supporting churches offer his services to his presiding elder to assist in evangelistic service in some neglected area.

(2) We urge all pastors to acquaint their constituency with the great work of the Memphis Methodist Hospital.

Every church conduct the Golden Cross Campaign in May.

This is our institution. It is doing more for us than we are doing for it. It deserves our increased support.

(3) Information gives inspiration. Therefore we recommend the great body of missionary literature for wider distribution. Our missionary magazine, *The World Outlook*, should be read by all our people.

We urge attendance upon the District Evangelistic Missionary Institutes to be held early in the year.

In keeping with the plans and objectives set by the Centennial Commission our committee on Evangelism recommends:



1. That we set as a goal for each local church in the conference a number of additions on profession of faith equal to ten per cent of the present total membership.

2. That a survey be made in each local church to locate the prospects for the christian life.

3. That a local committee on Evangelism be set up in each church equal in number to the goal set for that church; and that the prospects found in the survey be turned over to this committee after the pastor has carefully organized and trained it.

We suggest that the survey be made in December if possible and that personal work begin not later than Jan. 1st.

We are pleased to know that a goodly number of churches observed Oct. 25th as a day of Prayer and fasting.

Another such day may be set just before the pre-Easter revival campaign.

4. That a state-wide evangelistic rally be held about March 1st for the preparation of leaders for the revivals in local churches.

5. That the Presiding Elders schedule the District Conference consecutively so that such men as Bishop John M. Moore and other great leaders may visit them and bring inspiration.

We rejoice to note the reports of many good revival meetings during the year in which 3,747 were received into the church on profession of faith.

Our present total membership being 75,576. Our goal for the year is 7,557.

We have had a delightful year in the Orphanage in spite of the hectic conditions that prevail throughout our country. The financial statement is as follows:

We are happy to state that the Orphanage continues to stay on a strictly cash basis. For this achievement, we are indebted to the splendid management of our helpers, Mrs. S. J. Steed, Matron, and others at the Home, as well as to the advice of our Board.

At the beginning of the year, we had 31 children. During the year we have received 13, and have had 11 to leave us, and now we have a colony of 33. Up to the present time, we have placed 540 children in good homes throughout the United States.

Our children all attend Sunday School and Church services regularly at Highland where we have the pastoral over-sight of one of the most sympathetic

and helpful pastors that the Church has to give in the person of the Reverend O. L. Cole.

I feel that our endowment is steadily increasing. Including the proceeds from an estate which I have been working on for more than a year, we have approximately ten or twelve thousand dollars. I have several more sums in the offering which I hope to be able to close out in the course of time.

#### *Recommendations*

1. We request that you recommend to the Conference to give us the same assessment this year as they did last year, to-wit: \$2,400.00, each, with whatever scale the Budget Committee makes in all of the askings.

2. We recommend that the Boards of Christian Education accept, as they have heretofore done, this undertaking as a part of their work and that Brother Ira A. Brumley of the North Arkansas Conference and Brother Clem Baker of the Little Rock Conference, assist us as they usually do in this connection. If they do, nothing but success will follow.

3. We are convinced that the time has come when we might put forth some kind of an effort to raise funds for endowment for this institution because of its popularity with our people and we recommend that you authorize us without any general campaign to continue to secure endowment during the coming year. You will rejoice to know that we are already getting, as shown in the report, some gifts to this endowment fund and we feel now quite sure that we can raise a considerable sum if our brethren will take hold of the proposition.

Beside those built under his ministry many others were made possible by his leadership and his labors.

He loved his Church and was willing to spend and be spent for the cause of Christ. Personally, I knew him as few men know each other and I know

## STANDING RULES

OF THE

### North Arkansas Conference

---

1. That the Conference instructs the Commission on Budget, in apportioning assessments to the districts, to use the method laid down in the discipline for the General Boards in apportioning the assessments to Annual Conferences; provided, that said commission shall have power, subject to the approval of the Conference, to reduce the amount apportioned to any District for Conference Work, but the amount thus taken off any such District shall not be added to the apportionment of any other District or Districts.—1928 Journal.

2. That all undergraduates be required to report according to the call of the several committees before the opening of the Conference and that not one be allowed to take examination after Conference opening unless providentially hindered.—1914 Journal, page 32.

3. That the Conference Treasurer shall be allowed a commission of one per cent on all collections passing through his hands up to \$10,000 as compensation for his service, together with incidental expenses.—1918 Journal, page 30.

4. That the lay members of the District Conference, in addition to the lay members provided for by the Discipline, shall consist of one delegate from each Church in each Pastoral Charge; and, provided further, that when the membership of any church reaches three hundred, it shall be entitled to an additional delegate for each additional three hundred members or major fraction thereof, said delegate to be elected by the Quarterly Conference; provided, further, that no charge shall have fewer than three delegates elected.

5. That the figures answering the question: "Members reported last year," be the figures printed in the Journal of last Annual Conference.

6. That the Presiding Elders figures of all the assessments be accepted as the official figures.

7. That the assessments for Conference and General Work be combined in the statistical report; and, that the amount paid be the figures of the Conference Treasurer.

8. That the figures answering the question: "Amount raised for Missions by Sunday School," be the figures which represented the amount to the Treasurer of the Conference Sunday School Board.—1925 Journal, page 19.

9. That all Statistical reports shall be turned in to the Statistical Secretary; and that all settlements shall be made with the Conference Treasurer not later than 6 p. m., Thursday of Conference sessions or else the name of delinquents shall be reported to the Conference.—1916 Journal, page 32.

10. That the North Arkansas Annual Conference shall elect its Treasurer quadrennially, by ballot, without nominations, immediately after reading and passing upon the report of the Committee on Nominations; provided, that when a vacancy may occur from any cause, that on nomination of the Presiding Elder the Bishop in charge shall appoint some one to fill said vacancy.—1932 Journal.

11. When a member of this Conference becomes a member of the Bishop's Cabinet he shall automatically become ineligible to serve on any quadrennial board, committee, commission, or an officer in the Conference administration.—1932 Journal.
