## LITTLE ROCK CONFERENCE REPORTS

### REPORT NO. 2 OF BOARD OF CHRISTIAN EDUCATION

(Report No. 1 was in substance the same as that adopted by N. Arkansas Conference relating to Galloway College.)

Your Conference Board of Christian Education expresses to the Conference our appreciation of the good support given to our program and work by Bishop H. M. Dobbs, his cabinet, and the ministers and laymen of our Conference.

We commend the work of our Conference officers:

Miss Faye McRae, Director of Children's Division; Rev. H. D. Sadler, Director of Y. P. Division; Mr. J. S. M. Cannon, Director of Adult Division; Rev. Clem Baker, Executive Secretary; Rev. S. T. Baugh, Extension Secretary; Miss Lucile Slack, Office Secretary.

Your Board has approved a plan of work for next year whereby larger emphasis will be placed upon District organizations with the Presiding Elder as chairman, and Sunday School Day Funds raised in each District will be used for District promotion.

In view of the reduced income from Anniversary Day, we urge each District to make some provision for supplementing the work of the District Director of Young People's work in making its District Budget.

In order that the Conference may thoroughly understand the program we have outlined for next year we ask permission to submit this program and ask approval of the Conference for same.

We have elected the following as members of our Conference Joint Boards and Committees: James Thomas, C. J. Greene, H. H. Griffin, J. C. Glenn, J. D. Hammons, J. S. M. Cannon, Clem Baker, J. W. Mann, Board of Managers for Pastors' School; C. E. Hayes, J. S. M. Cannon, C. N. Baker, S. T. Baugh, on Joint Commission on Rural Life; A. C. Millar, Mrs. H. King Wade, Carl Hollis, Trustees of Western Methodist Assembly; R. E. L. Bearden, Miss Roxie Deal, E. C. Rule on Joint Committee with Board of Church Extension. For Executive Committee we have elected our chairman, secretary, treasurer and executive secretary, and authorized them to select three others conveniently located after the appointments have been read.

We have elected the following to the office indicated and request that

the Bishop appoint Clem Baker and S. T. Baugh to the office to which they have been elected. Executive Secretary of the Board of Christian Education, Clem Baker; Extension Secretary, S. T. Baugh; Director of Children's Division, Miss Fay McRae; Director of Young People's Division, Harold D. Sadler; Director of Adult Division, J. S. M. Cannon; and Miss Lucile Slack for such office secretary work as the Board can afford.

#### Recommendations

1. That the Commission on Budget be requested to make the following apportionment for the Board of Christian Education next year; \$8,000.00 for school and colleges; \$5,600.00 for Conference Promotion; \$1,136.00 for the Pastors' School, and that the income from the apportionment for schools and colleges be allocated to Hendrix College.

2. That after the per cent is deducted for the Pastors' School the remaining money received by the Board of Christian Education from the Conference assessment this year be distributed as follows:

41.18 per cent for Conference Promotion, and 58.82 per cent for the Colleges.

3. That first emphasis be placed upon the Christmas offering for our Orphanages in all church services held on Christmas Sunday, December 24.

4. That Sunday School Day and Young Peoples Anniversary Day be observed in all our churches and that each District set its goal for same.

5. We commend the work of the Western Methodist Assembly and urge our people to attend the schools and conferences held there during the Summer.

6. We recommend the following appointments: Professor, Emory University, R. C. Rhodes; Vice-President and Professor, Hendrix College, C. J. Greene.

7. That the Bishop and his cabinet appoint a commission to serve with a like commission from the North Arkansas Conference, to consider the whole matter of a celebration of a Semi-Centennial for Hendrix College and a Centennial for the Conferences in Arkansas.

8. That the Conference approve and authorize Retreats for the College, the College and executive secretary to work out the details with the Presiding Elders.

9. That the Pastors' School be held at Hendrix next year and financed by funds raised for that purpose this year.

10. We recommend a larger emphasis upon District work under direction of a District Staff, being set up in accord with the General Board Manual on District Organization, with the Presiding Elder as Chairman of the District Staff and a District Secretary to be appointed by the Executive Committee of the Board of consultation with the Presiding Elder of the District.—C. E. Hayes, Chairman; E. C. Rule, Secretary.

### REPORT OF THE BOARD OF TEMPERANCE AND SOCIAL SERVICE I.—Temperance:

In the repeal of the 18th Amendment, the temperance forces of America have lost a battle in the age-long warfare against alcohol, but there are many more battles to be fought. The duty of the present hour is to arm ourselves with a new faith in the cause and start at the very bottom until we have won another battle. We commend the preachers of the Little Rock Conference who stood out vigorously for the retention of the 18th Amendment in the recent state election. As we face the enemy today we recommend the following plan of attack:

1. The Church must continue to declare and to emphasize the basal truth, which no political action can change, that alcohol is a narcotic poison, which incapacitates men and women for citizenship, making them a menace to society and to their families.

We call attention of the Conference to the plan of temperance education which our Young People's Department of our church has launched against the evils of alcohol. Through our periodicals, our church is giving a great deal of worthwhile material in the educational program, and we thank our leaders for this. We urge every pastor to begin this educational endeavor at once, and secure a large number of signers among his membership, including youth and adults, of the "Statement of Purpose," as prepared by our Young People's Department.

The Church must avail itself of this weapon of education, which she has neglected during the era of Prohibition. An indispensable aid in the local church is the committee of Temperance and Social Service, which should function actively in the education against the evils of alcohol. We request every pastor to put this committee to work in his church.

2. There should be no weakening of the laws we now have to control liquor. The prohibition laws of Arkansas were passed before national prohibition, and we must endorse them and exert every effort to see that they are not weakened in any way. We hereby endorse the stand of Governor J. M. Futrell of Arkansas in refusing to include liquor legislation, should he call a special session of the Legislature.

3. We must continue to join with all others like-minded in the irrepresible warfare against the liquor traffic, among which forces are the Anti-Saloon League and the W. C. T. U. and other legitimate organizations. We commend the efforts of our own brother, Rev. J. H. Glass, who has worked quite efficiently as the superintendent of the Arkansas Anti-Saloon League, and we urge the brethren to cooperate with him.

#### II.—Social Relations:

1. Believing that "those who take

the sword perish by the sword," we register ourselves as opposed to competitive armaments by our Government. As a step toward peace we stand for the abolition of military training in schools and colleges. We urge our Sunday School teachers and pastors to help instill a spirit of good will toward all nations, as a fundamental element in building for permanent peace.

2. We call upon our pastors and people to take an intelligent interest in working for better social relations, and for the curbing of the increase of lynching.

3. We re-affirm our opposition to the 90-day divorce law of Arkansas and we urge our people and pastors to work for its repeal.

4. We deplore the growing lax attitude toward the observance of the Sabbath and request that our pulpits cry out in warning against evils that are undermining the respect and reverence for the Sabbath.

5. We endorse the forward step of our Federal Government in the abolition of child labor, and place ourselves on record favoring more Christian relations in industry. We endorse the action of the Government through the efforts of the President of the United States to bring about a more harmonious and equitable relationship between Capital and Labor.

6. We hereby express appreciation for the fine work of Rev. D. H. Colquette in visiting and conducting services in our penal, industrial and eleemosynary institutions, and for the unselfish service of Rev. J. F. Taylor in ministering in neglected areas.

In conclusion we recommend that the following who are members of the Conference Board of Temperance and Social Service, be appointed to represent the Little Rock Conference on the Arkansas Anti-Saloon League: W. Roy Jordan, Mrs. B. B. Leavies, W. C. Hilliard, W. J. Whiteside, Dr. A. C. Millar, and Fred R. Harrison.—W. Roy Jordan, Chairman; Fred R. Harrison, Secretary.

### REPORT OF COMMITTEE ON EVANGELISM

Your Committee on Evangelism rejoices in the large ingathering that has come to our Church both by profession and by certificate. In the great work being done in rural evangelism we feel that our pastors are answering the call of the Church when it said, "Let this be a quadrennium in which there shall be one dominant note—a passion for souls." With 2,587 additions on profession of faith we have a gain of 405 members over that of last year.

We urge that as leaders we do not confuse methods and passion, but that through our every effort there shall run one constant objective, the salvation of the lost and the development of the Church.

3. That some time during the early part of the year each Presiding Elder call his preachers and officials together for a Spiritual Life Conference.
4. That the Bishop in charge be requested to fix a special hour at the next session of the Annual Conference for special emphasis on the spiritual life values and that plans for the proper observance of this hour be made and announced as early in the year as possible.
5. We recommend the appointment of Rev. L. C. Gatlin as Conference Evangelist.—J. D. Hammons, Chairman; Leland Clegg, Secretary.

## OBSERVATIONS ON SESSION OF LITTLE ROCK CONFERENCE

**H**OT SPRINGS was host to Little Rock Conference last week and entertained royally. Dr. J. D. Hammons and the pastors and people of the churches handled everything handsomely, and all visitors seemed abundantly satisfied. Again Bishop Dobbs presided with his usual ease, dignity and grace, and on Sunday morning preached an edifying sermon on "Witnesses for Christ." As at the

North Arkansas Conference, organization was consummated Wednesday night and the sacrament of the Lord's Supper administered. Dr. C. J. Greene was re-elected secretary. On Thursday "Education" was the principal subject considered, and a paper on Galloway College similar to the one adopted by North Arkansas Conference, was adopted. In addition to the home speakers, Dr. W. F. Quillian, secretary of the General Board of Christian Education, spoke.

The following were elected delegates to General Conference: Clerical—James Thomas, J. D. Hammons, J. L. Cannon, C. M. Reyes, and J. L. Dedman; alternates—W. C. Watson, J. A. Henderson, C. J. Greene; lay—J. S. M. Cannon, J. P. Womack, Carl Hollis, Mrs. H. King Wade and Mrs. W. P. McDermott; alternates—C. E. Hayes, R. D. Lee, and Mrs. F. M. Williams.

Three young men who did not meet the educational requirements, were admitted by the two-thirds vote. There was a slight decrease in the collections; although some Districts showed a gain. The net membership increase was 2,161. This makes a net gain in the two Conferences in Arkansas of 4,700 last year. Now our total membership in the State is 137,363.

Dr. Ivan Lee Holt, pastor of St. John's Church, St. Louis, was the preacher. His strong, timely sermons edified and encouraged. Dr. Ben M. Spence, the renowned Canadian journalist, as at Jonesboro, delivered an illuminating address on the Canadian so-called System of Liquor Control, to a large and appreciative audience. The report of the Board of Temperance and Social Service was brief, but unusually felicitous and direct in pointing out evils and suggesting our attitude of unrelenting opposition to the liquor traffic in any and every form. Our governor's refusal to include any recommendation for liquor legislation was applauded, and the Arkansas Gazette's editorials against the evils of the liquor traffic and other evils were commended. Bishop Dobbs, by special request, delivered the memorial eulogy. On Armistice Day, the Bishop called the 14 preachers who had been in army service to the front and commended them for their patriotism.

The Conference accepted the invitation of First Church, Pine Bluff, for the next regular session; and adjourned to meet in special session at First Church, Little Rock, Jan. 18, at 10:00 a. m., to consider Kingdom Extension. The writer had a comfortable room in the Woodcock Apartments, with meals at the Moody Hotel. A wholesome noon lunch was served in the church by the women of the church. Many superannuates and wives of preachers were in attendance. The temper of the preachers was good and all seemed ready for hard and faithful service.

## REPORT OF CONFERENCE BOARD OF LAY ACTIVITIES

The church today is facing a new era in its history. The rapid social and economic changes of our day offer a challenge to the church the like of which we have not faced in half a century. The laymen of the church now see more clearly the need of placing emphasis upon the development of personality and personal worth in character and that this can best be done by bringing the church to a higher reverence and a closer allegiance to God.

The new program of the church has brought the ministry and the laity to sense a need of a new work of grace. "We have had form without power;" we have attended to things rather than men; now we need a new growth for a renewed spiritual life.

In recognition of the present efforts of the General Board of Lay Activities, we recommend:

- (1) A continuation of the program of Stewardship Training throughout the Church.
- (2) The holding of Stewardship Standard Training Classes in local churches.
- (3) That proper emphasis of this phase of the church work be given due consideration by the ministry from the pulpit.
- (4) That the whole church membership through these activities be

brought to appreciate more highly the importance of a consecrated life.

(5) The Conference Board of Lay Activities further recommends the utilization of the whole division organizations in the making of the every member canvass for Benevolences and as far as is practicable the raising of the Benevolences the first quarter of the year.

We recommend the election of J. S. M. Cannon, Conference Lay Leader and Robert D. Lee as Secretary-Treasurer.

## REPORT OF THE CONFERENCE BOARD OF MISSIONS

The Board of Missions is glad to say that the year closing has had in it elements of joy as well as much anxiety. We feel, however, that the income from our missionary operations has been satisfactory. The General Board at Nashville is in financial trouble by reason of the falling off of Benevolences throughout the Church, but in spite of all of this, we are breaking even every year. At our meeting last night, we had the report of Dr. Cram, our Secretary of the Board of Missions at Nashville, and we wish to express our appreciation of his approval and assure him and the Board that we will collaborate in every way possible in an effort to solve our problems. The report of Dr. Cram reveals to us the conditions.

We have had harmonious meetings of the Board of Missions and we have tried as your representatives of the Little Rock Conference to solve the problems that present themselves to us. The Board of Missions insists that the Secretary incorporate in this report the following resolution:

RESOLVED that as a Board, we thank Dr. James Thomas for his devotion to the work of Missions and for his leadership in our affairs.

We are interested in all things pertaining to missions and we are especially happy over the results of the work that is being done by the Extension Secretary in developing our churches in the open country.

We call your attention to the fact that all denominations, so far as we know, including the Roman Catholic Church, are putting on a program rich in information over the National and Columbia Radio Stations, which some of us have heard with interest and pleasure.

## Recommendations

We recommend the appointment of the Rev. J. F. Taylor as Conference Missionary.

We elect James Thomas, W. C. Watson and J. A. Henderson to serve on the Rural Church Commission. We understand that Dr. J. D. Hammons is an ex-officio member of this Commission by reason of his being chairman of one of the quadrennial com-

mittees and a member of the General Board of Missions.

We nominate Dr. J. D. Hammons, clerical, and Dr. R. E. Johns, layman, for membership on the General Board of Missions.

We are grateful to know that our Conference has paid \$3,085, which is only about 15 per cent less than was paid last year, and from this amount, we make the following appropriations for the incoming year:

#### REPORT OF BOARD OF CHURCH EXTENSION

Your Board of Church Extension submits the following report:

Lack of funds has made necessary the policy of the Board, to limit the assistance which we have been able to give, to those places only where necessity compelled our action in order to prevent abandonment of points now being held.

We have not been able to assist in any new building enterprises, and will not during the next Conference year.

We have co-operated, both with our churches in distress, and with the General Board in an effort to work out solutions in the most acute situations.

Some progress has been made along this line, and we wish to express our appreciation of the assistance and helpful counsel which Dr. T. D. Ellis, Secretary of the General Board has given us.

At the beginning of the year, we owed donation grants to Stephens and Oaklawn Churches aggregating \$1,000. We now have the money to pay these grants. We have also donated to Gum Springs Church on the Hot Springs Church Circuit, \$200.00, the parsonage on the Hickory Plains Circuit, \$200.00 and to Macedonia Church on the Princeton Circuit, \$50.00.

We made a loan to the DeValls Bluff Church of \$200.00. There remains a balance in the loan fund of a small amount as shown in the statement attached.

#### CONFERENCE BOARD OF FINANCE

##### Report No. 1

In this, our first report, we wish to call your attention to our Superannuate Endowment Movement. Since the beginning of the campaign, the church's claimants have received for their support from endowment income a total of \$2,517,986.17. Despite unprecedented economic conditions, the General Board of Finance reported at the close of the fiscal year March 31, 1933, an interest yield of 3½ per cent on the total capital of our Endowment Fund. Your General Board appropriated \$146,007.44 to claimants from the general fund at the close of the fiscal year March 31, 1933. This sum plus \$546.02 balance on hand from 1932 distribution made a total of \$146,553.46 for the 1933 distribution. In the general fund, we had a total capital of \$3,821,822.11, as of March 31, 1933. This represents an increase in capital for the fiscal year, which closed March 31, 1933, of \$23,155.45.

We are not trying to collect special funds in this movement now, but we are going to continue the best we can under the conditions through which the church is battling, hoping that the days ahead will be brighter.

Your Conference Board received from the Conference Superannuate Endowment Fund, handled by the Board of Finance, the sum of \$1,998.28, which amount, added to the other

#### PRESIDING ELDERS' REPORTS

##### ARKADELPHIA DISTRICT

funds which will come into our treasury, will be distributed among the claimants immediately following the adjournment of this session of our Conference.

For the information of the Conference, we state that your Conference Board will pay the claimants, beginning this year, largely on the basis of service years. Under the ruling of our General Board, we are required to consider service years in computing the amounts we pay them. It is, therefore, vitally important, in fairness and justice, that service years be correctly given in the Conference Journal. In order that you may understand the rules for computing service years, we give here as follows: "The net years of service of a superannuate are the years from the date of his admission on trial to the date of his superannuation, less the years he was located and supernumerary within that period; provided, however, that only two years "On Trial" can be counted.

"The net years of service of a preacher's widow are the years she was his wife during the time he was a traveling preacher in the effective relation (that is, during his "net years of service").

#### Recommendations:

The Camden District has enjoyed a year of substantial growth. Practically every department shows a very satisfactory increase. The department of Christian Education, including the Woman's Missionary Society and Young People's Division, will show a decided advance in enrollment and attendance. Three Christian Culture Institutes were held in which a large percentage of our young people took credit. No department is more alive and enthusiastic than that of our young people.

About 725 additions to the church have been received. Our revival efforts have conclusively evidenced the fact that Methodism still has a rich field in evangelism. One struggling church had 100 members added during and following a revival, making it necessary to convert it into a station. 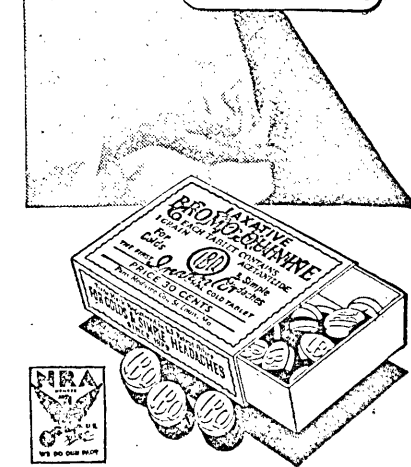

Your Treasurer is bonded by one of the leading Surety Houses of the United States, and all of the records, cancelled vouchers, cash books, and all items pertaining to the finances of the Board have been audited.

Below we give a report of the auditor.

"This is to certify that I, Roy G. Custer, have examined the records and bank books and items of the Board of Finance, including all records of the Treasurer, S. F. Hines, and find them to be in correct form with one exception, which I shall note at the bottom of this statement.

"We find that the Bank receipts or deposits and vouchers tally and that all records have been faithfully and accurately kept.

"I wish to commend the excellent system, which the Treasurer has adopted and has followed so well this year. I regard it as one of the most detailed and correct systems for work of this kind obtainable."

P. S.—The exception which I noted in checking the entire financial records of the Board of Finance is this: There is an apparent discrepancy of \$92.08 in the form of a plussage in the bank balance, as of December 1, 1932. In other words, the Board had \$92.08 more in the bank than the Cash Book of the Treasurer indicated. This is easily explained as follows: It came about from the bank crash two years ago and also the clearance of post-dated checks and the tying up of some funds which were not released at the time the financial report was submitted for the fiscal year ending November 30, 1932.—S. #### Report No. 2

Superannuate Homes and Miscellaneous Matters

We have five superannuate homes in our Conference, all of which are free of debt and in fair to good repair. Our only expenditures for these homes this year have been for the necessary taxes and insurance, a total of \$227.89 having been spent. They are conservatively valued at \$14,000.

Our home at Little Rock is now occupied by Rev. L. R. Sparks, who moved into it last June when it became necessary for him to give up his charge on account of his health. Prior to this occupancy the home was rented through the effort of Rev. W. C. Hilliard, pastor at Henderson.

Our home at Malvern is occupied by Rev. John P. Taylor by contract with the Board at the time of its erection.

Our home at Mena is partially occupied by Mrs. W. M. Worley.

Our homes at Arkadelphia are occupied by Rev. E. F. Wilson and family, and Mrs. W. W. Mills, respectively.

#### Miscellaneous Matters

It is our policy to keep our present homes free of debt, and to accept no property in the future unless it is desirable and free of debt.

It is also our policy, in making appropriations for our Conference claimants, to consider claimants living in homes owned by the Board, or those in rent free homes, in order that the appropriations to the claimants may represent equity and justice to all parties alike.—John C. ### BIBLE BOARD REPORT

Your Committee on the Bible Cause respectfully reports the continued excellent work of the American Bible Society, though the year has been marked by unusual problems and added responsibilities.

The translation of Scriptures has gone forward unabated. Nine new languages and dialects in which the Holy Scriptures are now available.

marks a real achievement in view of the paralyzing effect of the worldwide economic situation. It is good news to know that the China Agency reports a greater distribution than in any preceding year, and reports come also from Mexico and certain South American countries of an increase of distribution over last year.

Of special interest to this Conference is the report of Rev. J. J. Morgan, Agency Secretary for the Southwest. He reports for his area, Texas, Arkansas, Oklahoma and Louisiana, a distribution of 332,539 volumes in forty-one languages. Of the total copies distributed, 69,109 volumes were donated.

We heartily endorse the fine work of the Society, believing it to be essential to our whole Christian enterprise. We recommend the observance of Universal Bible Sunday, which occurs this year December 10th. "The Light Shined in Darkness" is the theme suggested for a sermon or address. Illustrating this theme, a packet of literature, also a beautiful poster, will be mailed to every pastor. No collection is asked; only a "hearing" for the Old Book.

We endorse the work of Rev. D. H. Colquette as agent for the Society and pledge him our support. We also endorse his work among the aged, infirm, poor and imprisoned. We recommend his appointment both as agent of the American Bible Society

and as superintendent of Institutional Mission work.—F. C. Cannon, Sec.

#### A PETITION TO THE ARKANSAS HIGHWAY COMMISSION

Whereas, the Western Methodist Assembly, on Mount Sequoyah, near Fayetteville, has a constituency of some 800,000 Methodists in seven states, is visited by thousands from all parts of the nation, and is a beauty spot which advertises our State in an unusually attractive way, and consequently is a great asset to our whole State, is not, in any sense, a private, local, or commercial enterprise; and, whereas, to accommodate the multitude of visitors and cause them more highly to appreciate the Assembly and patronize it, a thoroughly satisfactory road is sorely needed;

Therefore, be it resolved that the North Arkansas Conference of the Methodist Episcopal Church, South, with a constituency of some 250,000 occupying more than one-half of the state, hereby respectfully and earnestly requests the Arkansas Highway Commission to give favorable consideration to the petition of the Trustees of the said Assembly for the inclusion in the highway system of two miles of road leading to and around the Assembly grounds and for the completion of this road with a hard surface, and this request is made with feeling that by granting the petition of the Assembly Board, the State as a whole will be benefitted both financially and through the higher appreciation of our State by the thousands who will travel this Assembly road.

#### REPORT OF THE HOSPITAL BOARD

Your Board thoroughly appreciated the presence of Dr. C. C. Jarrell, Secretary of the General Hospital Board and his stirring message on the Gospel of Healing and his clear statement to your Board. We were gratified to learn that, in spite of diminished income and resources, the General Board has incurred no debt and expects to come to the General Conference without a deficit.

Dr. Jarrell informed us that the Board had been able to aid the Tubercular Hospital at Tucson, Arizona, to refinance its debt and operate even in the difficult conditions surrounding it. As it is our only connectional hospital, our only connectional institution west of the Rocky Mountains, and our only definite effort to care for tubercular patients, and as there is no hospital within the bounds of our own Conference, and, consequently, under our law, our Golden Cross contributions go to that worthy institution, we urge our pastors to encourage Golden Cross enrollment among our people to support the Hospital at Tucson.

We nominate Dr. A. C. Millar as Golden Cross director and request him to give special attention to promoting Golden Cross enrollment.

We recommend that the \$100 of our funds in the treasury of the General Board be appropriated for the use of the Tucson Hospital.

Mrs. H. King Wade and A. C. Millar were elected to represent our Conference Board at the meeting of the General Hospital Association that meets in Jackson, Miss., in May.

We recommend the adoption of the following memorial to General Conference:

In view of the fact that the last General Conference recommended that the General Hospital Board consider Hot Springs, Arkansas, as a suitable location for a great connectional hospital or sanatorium, if and when financial conditions make its

establishment possible without incurring debt; and because we believe that, at some time when such an institution can be prudently and successfully financed, our Church should have a connectional hospital or sanatorium at Hot Springs, which is recognized by the Federal Government as the greatest health resort in the world, we respectfully memorialize the next General Conference to take action similar to that of the General Conference of 1930.—A. C. Millar, Chairman; Mrs. F. M. Williams, Sec.

#### REPORT OF COMMITTEE ON CONFERENCE MERGER

WHEREAS, the Little Rock and North Arkansas Conferences raised a committee from each Conference for the purpose of studying the question of merging the Conferences; and
