## REPORT OF ARKADELPHIA DISTRICT

The Arkadelphia District has made progress along almost all lines this year. There was less complaint about finances than during any recent year, although crops were nearer a total failure than at any time within the recollection of most of the people and work for wages was almost impossible to find.

Our people have contributed of their means and a greater spirit of cheerful giving I have never seen. Our young men in many churches are becoming active workers as stewards and Sunday School Superintendents.

This District has one of the finest companies of young people I have seen and many are lining up earnestly in the work of the Kingdom.

There are 19 Charges in the District, 12 of which paid out in full on acceptances, 11 of these on both salaries and claims. The Sunday School Day Offerings were paid in full. The District work also was in full.

There were 651 additions to the Church. The Station receiving the greatest number being First Church. Hot Springs, 83, and the Circuit receiving the largest was Friendship Circuit, 73. Dalark Circuit entertained what we believe to be the largest District Conference ever held in Southern Methodism. It was estimated that at least 1700 people attended.

The parsonages at Dalark and Holly Springs have had substantial improvements.

The beautiful parsonage at Arkadelphia, built during the pastorate of Rev. R. E. L. Bearden, is being paid for by systematic giving and will soon be paid out.

The spiritual state of the Church is very gratifying. The times seem ripe for great revivals and our people are talking and thinking more of spiritual things than heretofore.

For this splendid year's work, we are grateful to Almighty God. To Him be all the praise.—J. A. Henderson, P. E.

## REPORT OF CAMDEN DISTRICT

This, our third year, has been the best on the Camden District. The pastors and laymen of every charge have manifested a spirit of loyalty in cooperation with every program of the Church and the District. I should like to comment in the highest appreciative terms of every pastor for none has been untrue nor neglectful of duties. We have been brothers in the common enterprise and have worked together. We have received a total of 1,002 members, 273 more than 1933, and our Benevolences amount to \$146 more than last year. We have had two Standard Training Schools, four Young People's Institutes, one Christian Adventure Assembly, one Bible Conference. In addition we have had from one to four Institutes for every Circuit except one. This is the work of Bro. Baugh who has been untiring in helping us in the rural sections.

In the three years we have paid an old District Parsonage debt of \$2.785, which the District Conference of 1929 obligated the District to pay the lender who financed its construction, and at the same time turned back to him the building. We have also purchased a

parsonage which is worth \$5,000 and cleared it of debt except about \$1,335. This has been no small task, but we have had the cooperation of the pastors and laymen and credit belongs to them.—J. L. Dedman, P. E.

#### REPORT OF PINE BLUFF DISTRICT

This has been a splendid year throughout the Pine Bluff District. The pastors have been faithful and in the main very acceptable to the people whom they serve.

We have had some wonderful revivals. Bro. J. D. Baker, our pastor at DeWitt, has had a gracious revival in his church, resulting in more than 100 conversions, he doing the preaching assisted by Bro. A. M. Hutton of Clarksville in the gospel of song. It is doubtful that the old town has ever been so stirred by a work of grace. E. T. Miller of Gillett has had a marvelous year, resulting in 206 conversions and reclamations within the bounds of his own work aside from conversions under his ministry with other pastors whom he assisted. ## THE LITTLE ROCK CONFERENCE

THE session of the Little Rock Conference, which L closed last Sunday at 4:15 p. m., was remarkable in several respects. The spiritual tone was unusually fine; the collections were better than last year; the increase in membership was 2,026; all real business was completed at noon Saturday and practically every appointment was known; and the entertainment and weather were perfect. Organizing Wednesday evening, the Conference was ready for routine business Thursday morning, and with short reports and brief speeches, under the superb presidency of Bishop John M. Moore, made rapid progress. At the anniversary of the Board of Christian Education Rev. Clem Baker, Dr. J. Q. Schisler, and Dr. O. S. Gates made admirable addresses; and at the anniversary of the Board of Missions Dr. W. G. Cram surpassed former deliverances in fullness of facts and force of delivery. The Bishop's morning talks were wonderfully helpful; his Sesqui-Centennial Address was informing and thought-provoking; his sermon Sunday morning was strong and inspiring; and his final exhortation, just before reading the appointments, was, in the opinion of many, the most challenging address ever heard on such an occasion.

The retirement of five Presiding Elders, under Bishop Moore's policy, required that many readjustments should be made. Knowing in advance that they would retire, these fine elders accepted their new appointments cheerfully, and the strong young men who take their places enter upon their work with confidence and courage. Dr. James Thomas, a great leader and efficient presiding elder, who has a connectional record for success in that office, will devote much of his time to promoting the welfare of the Methodist Orphanage, the wonderful institution to which he has so freely given time and thought. Rev. J. A. Henderson, who, with some pastoral intervals, has served five Districts and has the reputation of being a Sunday School promoter and holder of largely attended District Conferences in minimum time, retires, with a "marvelous" record, to the pastorate of Crossett, where he once served with full appreciation of the people of that ideal lumber community. The other three retiring elders had won recognition for their leadership, although their periods of "elderating" had been shorter.

The vote on the Presiding Elder question was taken by ballot and without debate, and the result was 124 for and 55 against the proposition. The Commission on Budget recommended the acceptance of the General Conference Askings and an equal amount for Conference Work, totaling \$90,428, and this was unanimously and cheerfully voted. At 3:00 p. m., on each of two days, Dr. J. D. Hammons and Dr. J. L. Cannon preached strong and helpful sermons. The attendance at all meetings was large, usually filling the big auditorium and galleries of First Church. Pine Bluff, with its handsome residences, paved streets and immense shade trees, presented a charming appearance and with its hospitality won encomiums from all. At 4:00 p. m., Friday, in the palatial residence of Mrs. J. F. Simmons, a largely attended and thoroughly enjoyed reception was given Mrs. J. M. Moore and other visitors. At the close of the session Sunday afternoon, the preachers sped homeward, or to their new appointments, with high resolve and eager courage to undertake what many believe will be the best year in our history. On the cordial invitation of First Church, El Dorado, the Conference voted to meet in that interesting city next year.—A. C. M.

## REPORT OF CONFERENCE DIREC-TOR OF SUPERANNUATE ENDOWMENT

As your Conference Director of Su-Perannuate Endowment I make the following report:

I attended the sixteenth annual meeting of our General Board of Finance in St. Louis, Missouri, April 16, last. I am pleased to report that this Board has so far survived the serious revolution in finance as well as those who are informed could expect. Last year the General Board collected on capital investment three and one-half per cent. The collections for the fiscal year, which closed March 31, 1934, show a slight reduction in interest collected, having earned only three per cent. However, there are now evidences everywhere that the storm is breaking and the worst is passed.

During the year various charges of the entire church have paid \$20,897.69 on their adjusted quotas. While this is not a large sum it is gratifying that even this much has been paid during a year when the pastors have been unable to collect more than 38 per cent on the regular Benevolences and sustained a considerable deficit on their own salaries.

Since 1924-25, the beginning of this movement, our Board has collected \$5,317,353.75. The total endowment in the hands of the Board is \$6,261,193.90. And, besides this there is \$53,923.68 in the reserve fund. There was available for distribution from the General Fund to the claimants, on July 1, 1934, \$142,-010.56. Our own Conference received \$1,678.40 on our Conference Fund handled by the Conference Board of Finance. At the close of the fiscal year there were 39 claimants on the General Board of Finance from the Little Rock Conference. They received a total of \$1.094.82 from our General Board this year.

We give you the foregoing for general information as touching the Superannuate Endowment movement at large and some facts connected with our own Conference claimants.—John C. Glenn, Conference Director.

## REPORT OF NEW BOARD OF CHRISTIAN EDUCATION

The old Board of Christian Education, having already reported on the work accomplished during the year just closed, your new Board confines its report to recommendations which must be approved by this Conference.

## Recommendations

1. That first emphasis be placed on the Christmas Offering for our Orphanage in all church services held on Christmas Sunday, December 23, and that the fifth Sunday in December be observed as Missionary Sunday in our Sunday Schools.

2. That Sunday, March 10, be observed as Young Peoples' Anniversary and that an offering be taken on this date in all our churches for the support of our Conference Young Peoples'

work. We recommend that a goal of \$1,000 be set for this offering.

3. That Sunday, April 7, or as near thereto as practicable, be observed as Church School Day and that an offering be taken for Christian Education with a goal of \$3600 for the Conference.

4. We commend the work of the Western Methodist Assembly at Mt. Sequoyah and urge our people to attend the schools and conferences held there during the summer. We have elected and ask that you approve Mrs. H. King Wade as our representative on the Board of Trustees of this Assem-


5. For the purpose of bringing about a closer relation between the local churches and Hendrix College, in keeping with General Conference Legislation (Par. 389), this Conference authorizes Hendrix College Week to be observed in each local church, including a sermon and a voluntary offering for the college. In line with successful experience in other Conferences, we recommend that at least three mass meetings be held within the bounds of the Conference in advance of Hendrix College Week to be addressed by the Bishop, some representative of the college and of the staff of the General Board of Christian Education. For Trustees at Large—Dr. James Thomas to succeed himself and Mr. H. K. Smith to succeed John Erskine for term expiring in 1939.

Alumni Trustees—Mrs. H. C. Mc-Kinney to succeed Mrs. H. W. Reinhardt, resigned for term expiring in 1939. Mrs. O. A. Graves to succeed Miss Beryl Henry, for a term of six years.

8. We had before us Dr. N. C. Mc-Pherson, Jr., representing Southern Methodist University and were happy to hear his report of the splendid work being done, especially in the School of Theology, for the training of young ministers. We sincerely urge our Presiding Elders to give careful attention to the appeal of this School of Theology for funds to help sustain young ministers from this Conference in training in this school.

9. Our Board was delighted to have Dr. J. Q. Schisler with us throughout its sessions representing the General Board of Christian Education and helping us to organize our work and plan our program for the new quadrennium. This Board is pledged to cooperate in every way with the plans and policies of our General Board.

10. The Board has taken seriously the responsibility placed upon it by the General Conference for educating our people in the evil effects of alcohol. The Board pledges its cooperation to the General Board in carrying out plans that are being developed in this field.

11. The Board deplores lynching and lawlessness in any form, because they tend to break down the respect of children and youth for law and order and degrade, if not destroy, their estimate of the worth of human personality which is basic in Christian education.

12. Your Board wishes to go on record as being in hearty accord with the aims and program of the Centennial Commission of Arkansas Methodism and pledges its support in every way possible in helping this commission to realize its objectives. We also want to go on record as being in hearty accord with the program and objectives of the Annual and General Conference Committees on Evangelism. We believe that the Sunday School offers the richest field for the right kind of evangelistic effort and pledge ourselves to renewed emphasis at this point.

13. We recommend the following appointments: Professor at Emory University, R. C. Rhodes; Vice-President and Professor at Hendrix College, C. J. Greene; Student, Duke University, John William Hammons; Student, Southern Methodist University, R. W. Menard.

14. We have appointed the following as members of joint committees: With the Board of Missions, Leland Clegg, C. K. Wilkerson and Clem Baker; With the Board of Church Extension, R. A. Terry, C. M. Reves and S. T. Baugh.

15. We requested the Commission on Budget to make the following apportionments for the Board of Christian Education next year: \$6,000 for Schools and Colleges; \$6,100 for Conference Promotion; \$1,134 for the Pastors' School, and that the income from the apportionment for Schools and Colleges be allocated to Hendrix College.

16. We have elected Clem Baker Executive Secretary and S. T. Baugh Extension Secretary, and request the Bishop to appoint them to the offices indicated. We have elected Miss Faye McRae, Director of the Childrens' Division; Harold D. Sadler, Director of the Young People's Division and W. E.

Silliman, Director of the Adult Division. We have authorized our Executive Secretary to select his office secretary.

17. For Executive Committee, we have elected our Chairman, Secretary, Treasurer, and Executive Secretary and have authorized them to select three others conveniently located with reference to the headquarters of our Conference Board.

18. The following have been elected officers of the Board: Chairman, Leland Clegg, Vice-Chairman, W. E. Silliman, Secretary, R. B. Moore, Treasurer, C. K. Wilkerson.

Finally, this Board wishes to pledge the Conference its very best effort in carrying on a full program of Christian Education within the bounds of our Conference and earnestly requests the cooperation of all the members of this Conference in the discharge of the heavy responsibility which has been placed upon us.—Leland Clegg, Chairman; R. B. Moore, Secretary.

## REPORT OF BOARD OF LAY ACTIVITIES

Your Board of Lay Activities believes that our Church is facing one of the most crucial tests of its long and glorious history as it endeavors to put into effective operation the New Financial Plan adopted by the last General Conference. While we think the plan offers great possibilities for developing our membership in Christian Stewardship so as to result in a new vision, zeal, loyalty, and consecration, we are not unmindful of the grave dangers which will attend a wrong attitude to the whole program of our Church on the part of our people. It will be disastrous in the extreme to the whole program of the Church, unless accepted and practiced in spirit and principle. That the full possibilities of the plan may be realized, we recom-

1. That mass meetings of stewards and other church officers be held in each District as soon as practicable after the session of the Annual Conference for the purpose of giving information concerning the New Financial Plan and creating an inspiration for the acceptance by every Quarterly Conference of an amount for General and Conference Work that will properly represent each charge in the benevolent program of our Church. That the Presiding Elder and District Lay Leader give direction to all the details of the program.

2. That one-half of the Benevolences be raised the first half of the Conference year, culminating in an offering for the Benevolences at Easter.

3. That proper emphasis on the Benevolences and the New Financial Plan be given at the sessions of the District Conferences.

4. That a Conference-wide meeting of the Presiding Elders, Pastors, and all lay leaders (Chairman of Boards of Stewards)be held early in the calendar year to plan for a Conference-wide campaign of Evangelism and for emphasis on the Benevolences; that the Bishop and the Conference lay leader be requested to give direction and leadership to all the necessary details of this movement.

I. Christian Stewardship.—Christian Stewardship furnishes a background for the proper understanding of a laymen's responsibility to God and His Church, and offers a worthy incentive for the fulfillment of that responsibility, and thus lays a solid foundation upon which the Church can build permanently.

We are gratified to note that progress has been made in this field. The Discipline instructs that "a definite period during the year, preferably at a

time when no immediate financial objective is in view, shall be designated in which major emphasis shall be given to the study and promotion of Stewardship principles." We recommend that in each church in the Conference this period of study and promotion be observed during the months of January, February and March, 1935, and that Stewardship Study Classes be promoted in the following ways:

1. Courses in Stewardship in Standard Training Schools.

2. Use of a Standard Class when the Standard School is not feasible.

3. The Stewardship Course as an Elective for one quarter in the organized classes of the Church School instead of the regular International Lessons, using as a text Dr. Crawford's Book, "The Stewardship Life."

We should magnify the Benevolences as a challenging Stewardship objective worthy of the finest and best response our people can make.



tor, wherever it is practicable, for fellowship, study, and personal evange-

When Jesus said: "Follow me, and I will make you fishers of men," he was speaking to us. We believe that the greatest undeveloped asset of our Church today is its man-power. The great need is for men workers. Our Bishops have suggested a goal of 750,-000 new members for this quadrennium. Certainly we should not expect to do less. Therefore, we urge increased evangelistic effort through educational processes, mass appeals, and personal contacts looking toward that perfect day when all men shall acknowledge our Saviour as Lord and Master.

III. Laymen's Day.—We recommend the continued observance of Laymen's Day and ask that the Conference designate the second Sunday in June, 1935, for this purpose; we urge that a Layman's Day Service be held in every church on that day, as far as possible. The theme for 1935 is: We are in the Fight for—(1) The Christian Home; (2) A Christian Industrial Order; (3) A Sober Nation; (4) A Warless World.

IV. The Church Press.-We commend the merging of The Methodist Layman with the Christian Advocate and heartily accept the opportunity and responsibility involved. We suggest as our immediate goal, "Every member of the Board of Stewards a reader of the Christian Advocate."

But in using and promoting the circulation of our general organ, we must not by any means make less use of our own Conference Organ, the Arkansas Methodist. For this paper we urge the goal, "The Arkansas Methodist in every Methodist family."

V. Training Official Boards,-Progress has already been made in this field. The work should be extended and intensified. For this purpose we recommend the holding of an Institute for Stewards in every District, and the organization of Boards of Stewards into study groups to study: "The Board of Stewards" by George L. Morelock, and "Financial Recovery for the Local Church" by J. E. Crawford.

VI. Support of the Ministry.-We recognize the fact that a large number of our preachers do not receive an adequate support. They and their families have been forced to bear excessive hardships and to deny themselves many things that would have contributed to their efficiency, usefulness and happiness. We would insist that

every Board of Stewards, after consultation with the pastor as to what is necessary for his support, shall regard the amount fixed as a moral obligation not to be loosely abrogated. We insist, also, that every Board of Stewards as far as possible, provide for the needs of the pastor on the basis of monthly payments of his salary.

VII. Social Service.—The responsibility which the last General Conference has given the Board of Lay Activities in charging it with the task of promoting the ideals of Jesus as they relate to great social obligations is felt with a keen sense of its enormity. The task is far-reaching and challenges the best there is in clergy and laity alike. The Social Creed adopted by the last General Conference should be called to the attention of our people. We call attention to some specific problems which any sane program of social service must take into account:

- 1. Motion Pictures .- The great educational value of the motion picture is well established both in theory and in practice. The serious question is in the kind of education which the youth of America, and the adult life as well, are receiving through this certain and positive teaching agency. We commend the League of Decency, and believe that our people should be encouraged to join. We believe that all Christian forces should join hands to eliminate from the screen the continued glorification of drinking, sex-appeal, gangsters, and harlots; and should demand the exaltation of decency, obedience to law, and respect for righteousness;
- 2. The present attitude toward the sanctity of the home is appalling, and calls for thoughtful and courageous effort to restore the ideals which have made possible the Christian family. One of the most disintegrating forces touching the American home being the veritable flood of salacious literature which, in many instances, is inundating our wholesome family life;
- 3. Because of our geographical location, our Church should be intensely interested in right race relations. The race problem is one of the greatest social problems in our national life. Its solution is difficult but is of great significance:
- 4. The problem of peace is of the utmost importance to the civilized world. The Christian Church is under command of the Prince of Peace and should be instant in season and out in building a body of sentiment unfavorable to war and insistent upon universal peace.
- 5. Touching our economic order, we quote from the report of our General Board of Lay Activities: "The recent disastrous years have called marked attention to the suffering and loss of morals occasioned by the inadequate distribution of wealth and income, to numerous and deplorable practices in our economic system, to the detriment of the masses especially. People everywhere are seeking a readjustment of our economic life in which, in the midst of plenty, want, destitution, and pathos will not exist. An adequate solution will be found only in the teachings of
- 6. And lastly we call attention to the growing menace of the liquor problem. This great moral and social evil is far from being solved. Christians are surely more aware today than ever before that people cannot drink themselves to sobriety. The Christian forces of America represent the only agencies through which an adequate program of temperance education and practice may be expected to channel. and all arms of the Christian Church should be constantly employed to the end that America may become not only the "land of the free and the home

of the brave," but the home of decency, sobriety, social and economic justice, racial and governmental peace, and a leader in the universal brotherhood of man.

#### A MESSAGE FROM DR. FORNEY HUTCHINSON

As I turn my face once more towards the Golden West, I want to convey through your paper a parting word to my brethren of the Little Rock Conference and my friends in Arkansas.

When I left Washington City just a month ago I had no thought but to spend the remainder of my days in my native State. With that end in view I furnished, at considerable expense, a little home my wife inherited from her mother on Welch Street in Little Rock. This plan was very pleasing to me, and the warmth of my welcome from my brethren and friends was very gratifying.

However, I had no more than reached home until the Boston Avenue Church in Tulsa began to press on me my responsibility with reference to a very critical situation that exists there. For several years they had done this, but this time they seemed absolutely desperate and their appeal grew more and more irresistible. At last, agreement with the two Bishops involved, I agreed to go. I did this cheerfully, reluctant only because it meant that I must again leave my native State and my home Conference. To the Members of Winfield Church

Dear Friends:

I am sure you would be interested in a detailed report of the year's work which has just been completed. I shall try to give you the substance of the report which your pastor made to the Annual Conference last week.

We received into the church 127 new members, and lost by death and by transfer to other churches 107. The net gain of 20 put our total membership at 1,995. Several times during the year we were over 2,000, but many transfers out lowered our figure for the Conference report. We reported 269 active members of the Women of Winfield and 80 in our Epworth Leagues. Our Church School membership is 1,119.

On a \$2,000.00 assessment for Benevolences we paid our claims in full, and all salaries in full. The women raised a total of \$2,539.00 and the Church School a total of \$1,803.00. In addition to these figures we raised \$16,495.00, or a total of \$20,837.00 for the year. This figure includes the \$2,000.00 paid on interest on the church debt; and the interest and \$350.00 which the women paid on the parsonage debt.

To Mr. Markham for his fine leadership of the Finance Committee; to the men who worked their lists loyally; and to the members who gave liberally I would give assurance of my genuine gratitude. Your loyal support of your church through the year has been encouraging to your pastor; and I am sure you share his joy in this good report.

Let us not rest. We are happy, but not satisfied. Let us enter the new year with the fine spirit which marked the close of the old year and move on for greater achievements. I am happy in the prospects of another year's work with you and am counting on your full co-operation.
